STUART L. RESCH, M.D., represents that all of the following statements are true:

That on or about February 28, 1974, I was licensed to practice as a physician in the State of New York, and issued License No. 118987 by the New York State Education Department.

My current address is



and I will advise the Director of the Office of Professional Medical Conduct of any change of address.

I am currently subject to BPMC Order # 08-152 (Attachment I) (henceforth "Original Order"), which went into effect on August 25, 2008, and was issued upon an Application For Consent Order signed by me (henceforth "Original Application"), adopted by the Original Order. I hereby apply to the State Board for Professional Medical Conduct for an Order (henceforth "Modification Order"), modifying the Original Order, as follows:

The sanction imposed in the Original Order was, as follows:

Pursuant to § 230-a(2) of the Public Health Law, my medical license to practice medicine shall be suspended for a period of thirty-six (36) months, the term of said suspension to be stayed.

Pursuant to § 230-a(9) of the Public Health Law, I shall be placed on probation for a period of thirty-six (36) months, subject to the terms set forth in attached Exhibit "B."

The sanction imposed shall be modified to substitute the following sanction for the one previously imposed:

Pursuant to N.Y. Pub. Health Law § 230-a(6), Respondent shall be subject to a limitation precluding registration or issuance of any further license.

and

The following Conditions shall be imposed upon Respondent:

That Respondent, who does not currently practice medicine in the State of New York, shall be precluded from practicing medicine in New York State, from practicing in any setting where his practice is based solely on his New York license, and from further reliance upon Respondent's New York license to practice medicine to exempt Respondent from the licensure, certification or other requirements set forth in statute or regulation for the practice of any other profession licensed, regulated or certified by the Board of Regents, Department of Education, Department of Health or the Department of State; and

That if Respondent is currently registered to practice medicine in New York State, Respondent shall, within 30 days of the issuance of the Modification Order, notify the New York State Education Department, Division of Professional Licensing Services, that Respondent's license status is "inactive," and shall provide proof of such notification to the Director of OPMC immediately upon having done so. This Modification Order shall strike the Condition in the Original Order requiring Respondent to maintain active registration of Respondent's license with the New York State Education Department, Division of Professional Licensing Services to pay all registration fees; and

That Respondent shall comply with all conditions set forth in attached Exhibit "C" ("Requirements for Closing a Medical Practice").

All remaining Terms and Conditions will continue as written in the Original Order, except that Exhibit "B" of the Original Order ("Terms of Probation") shall be of no effect.

I stipulate that my failure to comply with any conditions of this Order shall constitute misconduct as defined in N.Y. Educ. Law § 6530(29).

I agree that if I am charged with professional misconduct in future, this Modification Order shall be admitted into evidence in that proceeding.


I make this Application of my own free will and accord and not under duress, compulsion or restraint, and seek the anticipated benefit of the requested Modification. In

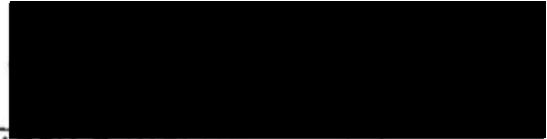

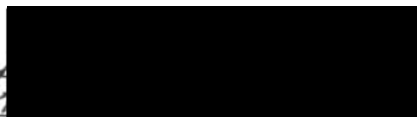

EXHIBIT "C"

Requirements for Closing a Medical Practice (Following Agreement to Never Register/Never Practice)

1. Respondent shall immediately cease and desist from engaging in the practice of medicine in New York State, or under Respondent's New York license, in accordance with the terms of the Order. In addition, Respondent shall refrain from providing an opinion as to professional practice or its application and from representing that Respondent is eligible to practice medicine in New York or pursuant to a New York license.
2. Within 5 days of the Order's effective date, Respondent shall deliver Respondent's current biennial registration, if any, to the Office of Professional Medical Conduct (OPMC) at Riverview Center, 150 Broadway, Suite 355, Albany, New York 12204-2719.
3. Within 15 days of the Order's effective date, Respondent shall, with regard to New York practice or practice anywhere pursuant to Respondent's New York license, notify all patients of the cessation of Respondent's medical practice, and shall refer all patients to another licensed practicing physician for continued care, as appropriate. Respondent shall notify, in writing, each health care plan with which the Respondent contracts or is employed, and each hospital where Respondent has privileges, that Respondent has ceased medical practice. Within 45 days of the Order's effective date, Respondent shall provide OPMC with written documentation that all patients and hospitals have been notified of the cessation of Respondent's medical practice.
4. Respondent shall, with regard to New York practice or practice anywhere pursuant to Respondent's New York license, make arrangements for the transfer and maintenance of all patient medical records. Within 30 days of the Order's effective date, Respondent shall notify OPMC of these arrangements, including the name, address, and telephone number of an appropriate and acceptable contact persons

who shall have access to these records. Original records shall be retained for at least 6 years after the last date of service rendered to a patient or, in the case of a minor, for at least 6 years after the last date of service or 3 years after the patient reaches the age of majority, whichever time period is longer. Records shall be maintained in a safe and secure place that is reasonably accessible to former patients. The arrangements shall include provisions to ensure that the information in the record is kept confidential and is available only to authorized persons. When a patient or a patient's representative requests a copy of the patient's medical record, or requests that the original medical record be sent to another health care provider, a copy of the record shall be promptly provided or forwarded at a reasonable cost to the patient (not to exceed 75 cents per page.) Radiographic, sonographic and similar materials shall be provided at cost. A qualified person shall not be denied access to patient information solely because of an inability to pay.

5. In the event that Respondent holds a Drug Enforcement Administration (DEA) certificate for New York State, Respondent shall, within fifteen (15) days of the Order's effective date, advise the DEA, in writing, of the licensure action and shall surrender his DEA controlled substance privileges for New York State to the DEA. Respondent shall promptly surrender any unused DEA #222 U.S. Official Order Forms Schedules 1 and 2 for New York State to the DEA. All submissions to the DEA shall be addressed to Diversion Program Manager, New York Field Division, U.S. Drug Enforcement Administration, 99 Tenth Avenue, New York, NY 10011.
6. Within 15 days of the Order's effective date, Respondent shall return any unused New York State official prescription forms to the Bureau of Narcotic Enforcement of the New York State Department of Health. If no other licensee is providing services at Respondent's practice location, Respondent shall properly dispose of all medications.
7. Within 15 days of the Order's effective date, Respondent shall, with regard to New York practice or practice anywhere pursuant to Respondent's New York license, remove from the public domain any representation that Respondent is eligible to practice medicine, including all related signs, advertisements, professional listings

(whether in telephone directories, internet or otherwise), professional stationery or billings. Respondent shall not share, occupy, or use office space in which another licensee provides health care services.

8. Respondent shall not, with regard to New York practice or practice anywhere pursuant to Respondent's New York license, charge, receive or share any fee or distribution of dividends for professional services rendered by Respondent or others while Respondent is barred from engaging in the practice of medicine. Respondent may be compensated for the reasonable value of services lawfully rendered, and disbursements incurred on a patient's behalf, prior to the Order's effective date.
9. If Respondent is a shareholder in any professional service corporation organized to engage in the practice of medicine in New York, Respondent shall divest all financial interest in the professional services corporation, in accordance with New York Business Corporation Law. Such divestiture shall occur within 90 days. If Respondent is the sole shareholder in a professional services corporation, the corporation must be dissolved or sold within 90 days of the Order's effective date.
10. Failure to comply with the above directives may result in a civil penalty or criminal penalties as may be authorized by governing law. Under N.Y. Educ. Law § 6512, it is a Class E Felony, punishable by imprisonment of up to 4 years, to practice the profession of medicine when a professional license has been suspended, revoked or annulled. Such punishment is in addition to the penalties for professional misconduct set forth in N.Y. Pub. Health Law § 230-a, which include fines of up to \$10,000 for each specification of charges of which the Respondent is found guilty, and may include revocation of a suspended license.

Stuart L. Resch, M.D., representing that all of the following statements are true, deposes and says:

That on or about February 28, 1974, I was licensed to practice as a physician in the State of New York, and issued License No. 118987 by the New York State Education Department.

My current address is [REDACTED], and I will advise the Director of the Office of Professional Medical Conduct of any change of address.

I understand that the New York State Board for Professional Medical Conduct (Board) has charged me with four specifications of professional misconduct.

A copy of the Statement of Charges, marked as Exhibit "A", is attached to and part of this Consent Agreement.

I plead no contest to the First Specification, in full satisfaction of the charges against me, and agree to the following penalty:

Pursuant to Section 230-a(2) of the Public Health Law, my medical license to practice medicine shall be suspended for a period of thirty-six (36) months, the term of said suspension to be stayed.

Pursuant to Section 230-a(9) of the Public Health Law, I shall be placed on probation for a period of thirty-six (36) months, subject to the terms set forth in the attached Exhibit "B".

I further agree that the Consent Order shall impose the following conditions:

That Respondent shall remain in continuous compliance with all requirements of N.Y. Educ Law § 6502 including but not limited to the requirements that a licensee shall register and continue to be registered with the New York State Education Department (except during periods of actual suspension) and that a licensee shall pay all registration fees. Respondent shall not exercise the option provided in N.Y. Educ. Law § 6502(4) to avoid registration and payment of fees. This condition shall take effect 30 days after the Consent Order's effective date and will continue so long as Respondent remains a licensee in New York State; and

That Respondent shall cooperate fully with the Office of Professional Medical Conduct (OPMC) in its administration and enforcement of this Consent Order and in its investigations of matters concerning Respondent. Respondent shall respond in a timely manner to all OPMC requests for written periodic verification of Respondent's compliance with this Consent Order. Respondent shall meet with a person designated by the Director of OPMC, as directed. Respondent shall respond promptly and provide all documents and information within Respondent's control, as directed. This condition shall take effect upon the Board's issuance of the Consent Order and will continue so long as Respondent remains licensed in New York State.

I stipulate that my failure to comply with any conditions of this Consent Order shall constitute misconduct as defined by N.Y. Educ. Law § 6530(29).

I agree that, if I am charged with professional misconduct in future, this Consent Agreement and Order **shall** be admitted into evidence in that proceeding.

I ask the Board to adopt this Consent Agreement.

I understand that if the Board does not adopt this Consent Agreement, none of its terms shall bind me or constitute an admission of any of the acts of alleged misconduct; this Consent Agreement shall not be used against me in any way and shall be kept in strict confidence; and the Board's denial shall be without prejudice to the pending disciplinary proceeding and the Board's final determination pursuant to N.Y. Pub. Health Law.

I agree that, if the Board adopts this Consent Agreement, the Chair of the Board shall issue a Consent Order in accordance with its terms. I agree that this Consent Order shall take effect upon its issuance by the Board, either by mailing of a copy of the Consent Order by first class mail to me at the address in this Consent Agreement, or to my attorney by certified mail, OR upon facsimile transmission to me or my attorney, whichever is first. The Consent Order, this agreement, and all attached Exhibits shall be public documents, with only patient identities, if any, redacted. As public documents, they may be posted on the Department's website.

I stipulate that the proposed sanction and Consent Order are authorized by N.Y. Pub. Health Law §§ 230 and 230-a, and that the Board and OPMC have the requisite powers to carry out all included terms. I ask the Board to adopt this

Consent Agreement of my own free will and not under duress, compulsion or restraint. In consideration of the value to me of the Board's adoption of this Consent Agreement, allowing me to resolve this matter without the various risks and burdens of a hearing on the merits, I knowingly waive my right to contest the Consent Order for which I apply, whether administratively or judicially, I agree to be bound by the Consent Order, and I ask that the Board adopt this Consent Agreement.

I understand and agree that the attorney for the Department, the Director of OPMC and the Chair of the Board each retain complete discretion either to enter into the proposed agreement and Consent Order, based upon my application, or to decline to do so. I further understand and agree that no prior or separate written or oral communication can limit that discretion.

STATEMENT
OF
CHARGES

Stuart L. Resch, M.D., the Respondent, was authorized to practice medicine in New York State on or about February 28, 1974, by the issuance of license number 118987 by the New York State Education Department.

FACTUAL ALLEGATIONS

- A. Respondent provided medical treatment to Patient A, 54 years of age, at the Emergency Department at Catskill Regional Medical Center, Catskill, New York, on April 4, 2000. Patient A, who had end stage renal disease and was on hemodialysis, presented with a fever and cough. Respondent's care and treatment of Patient A failed to meet minimal standards of care in that:
1. Upon diagnosing that Patient A had pneumonia, Respondent failed to admit said patient to the hospital for indicated treatment, including, among other things, IV antibiotics.
- B. Respondent provided medical treatment to Patient B, 43 years of age, at the Emergency Department at Catskill Regional Medical Center, on February, 1, 2001. Patient B presented with overwhelming dehydration, metabolic acidosis and respiratory failure. Respondent's care and treatment of Patient B failed to meet minimal standards of care in that:
1. Respondent failed to perform an indicated endotracheal intubation of Patient A; and

2. Respondent failed to appropriately attempt to resuscitate Patient A prior to said patient's cardiopulmonary arrest.
- C. Respondent provided medical treatment to Patient C, 78 years of age, at the Emergency Department at Catskill Regional Medical Center, on November 18, 2000. Patient C, who had a history of hypertension, diabetes, coronary artery bypass grafting and a cerebral vascular accident, presented to the Emergency Department with a tremor of the left hand, facial twitching, confusion and disorientation. Respondent's treatment of Patient C failed to meet minimal standards of care in that:
1. Respondent failed to diagnose that Patient C was suffering from hypoglycemia;
 2. Respondent failed to check Patient C's glucose level; and
 3. Respondent failed to give Patient C indicated IV glucose.
- D. Respondent provided medical treatment to Patient D, 32 years of age, at the Emergency Department at Catskill Regional Medical Center, on May 12, 2003. Patient D presented with a complaint of chest pain. Respondent's treatment of Patient D failed to meet minimal standards of care in that:
1. Respondent failed to admit Patient D to the hospital for ongoing treatment and evaluation of said patient's symptoms.
- E. Respondent provided medical treatment to Patient E, 59 years of age, at the Emergency Department at Catskill Regional Medical Center, on August 3, 2002. Patient E, who has a history of myocardial infarction in 1999, present with complaints of bilateral leg pain. Respondent's treatment of Patient E failed to meet minimal standards of care in that:
1. Respondent inappropriately discharged patient E from the hospital, failed to evaluate and treat said patient for a deep vein thrombosis.

- F. Respondent provided medical treatment to Patient F, 72 years of age, at the Emergency Department at Catskill Regional Medical Center, on June 19, 2003. Patient F presented with complaints of numbness and tingling on the left side of the body. A CT scan of Patient F's brain was performed. Respondent's treatment of Patient D failed to meet minimal standards of care in that:
1. Respondent failed to appropriately interpret the CT scan performed of Patient F's brain.

FIRST SPECIFICATION

NEGLIGENCE ON MORE THAN ONE OCCASION

Respondent is charged with committing professional misconduct as defined in New York Education Law Section 6530(3) by practicing the profession of medicine with negligence on more than one occasion in that Petitioner alleges the facts of two or more of the following:

1. The facts in paragraphs A and A1; B and B1, and B and B2; C and C1, C and C2, and C and C3; D and D1; E and E1; and F and F1.

EXHIBIT "B"

Terms of Probation

1. Respondent's conduct shall conform to moral and professional standards of conduct and governing law. Any act of professional misconduct by Respondent as defined by N.Y. Educ. Law §§ 6530 or 6531 shall constitute a violation of probation and may subject Respondent to an action pursuant to N.Y. Pub. Health Law § 230(19).
2. Respondent shall maintain active registration of Respondent's license (except during periods of actual suspension) with the New York State Education Department Division of Professional Licensing Services, and shall pay all registration fees.
3. Respondent shall provide the Director, Office of Professional Medical Conduct (OPMC), Hedley Park Place, 433 River Street Suite 303, Troy, New York 12180-2299 with the following information, in writing, and ensure that this information is kept current: a full description of Respondent's employment and practice; all professional and residential addresses and telephone numbers within and outside New York State; and all investigations, arrests, charges, convictions or disciplinary actions by any local, state or federal agency, institution or facility. Respondent shall notify OPMC, in writing, within 30 days of any additions to or changes in the required information.
4. Respondent shall cooperate fully with, and respond in a timely manner to, OPMC requests to provide written periodic verification of Respondent's compliance with the terms of this Consent Order. Upon the Director of OPMC's request, Respondent shall meet in person with the Director's designee.
5. Respondent's failure to pay any monetary penalty by the prescribed date shall subject Respondent to all provisions of law relating to debt collection by New York State, including but not limited to: the imposition of interest, late payment charges and collection fees; referral to the New York State Department of Taxation and Finance for collection; and non-renewal of permits or licenses [Tax Law § 171(27); State Finance Law § 18; CPLR § 5001; Executive Law § 32].
6. The probation period shall toll when Respondent is not engaged in active medical practice in New York State for a period of 30 consecutive days or more. Respondent shall notify the Director of OPMC, in writing, if Respondent is not currently engaged in, or intends to leave, active medical practice in New York State for a consecutive 30 day period. Respondent shall then notify the Director again at least 14 days before returning to active practice. Upon Respondent's return to active practice in New York State, the probation period shall resume and Respondent shall fulfill any unfulfilled probation terms and such additional requirements as the Director may impose as reasonably relate to the matters set forth in Exhibit "A" or as are necessary to protect the public health.

7. The Director of OPMC may review Respondent's professional performance. This review may include but shall not be limited to: a review of office records, patient records, hospital charts, and/or electronic records; and interviews with or periodic visits with Respondent and staff at practice locations or OPMC offices.
8. Respondent shall maintain complete and legible medical records that accurately reflect the evaluation and treatment of patients and contain all information required by State rules and regulations concerning controlled substances.

PRACTICE MONITOR

9. Within thirty days of the effective date of the order, Respondent shall practice medicine only when monitored by a licensed physician, board certified in an appropriate specialty, ("practice monitor") proposed by Respondent and subject to the written approval of the Director of OPMC.
 - a. Respondent shall make available to the monitor any and all records or access to the practice requested by the monitor, including on-site observation. The practice monitor shall visit Respondent's medical practice at each and every location, on a random unannounced basis at least monthly and shall examine a selection (no fewer than 20) of records maintained by Respondent, including patient records, prescribing information and office records. The review will determine whether the Respondent's medical practice is conducted in accordance with the generally accepted standards of professional medical care. Any perceived deviation of accepted standards of medical care or refusal to cooperate with the monitor shall be reported within 24 hours to OPMC.
 - b. Respondent shall be solely responsible for all expenses associated with monitoring, including fees, if any, to the monitoring physician.
 - c. Respondent shall cause the practice monitor to report quarterly, in writing, to the Director of OPMC.
 - d. Respondent shall maintain medical malpractice insurance coverage with limits no less than \$2 million per occurrence and \$6 million per policy year, in accordance with Section 230(18)(b) of the Public Health Law. Proof of coverage shall be submitted to the Director of OPMC prior to Respondent's practice after the effective date of this Order.
10. Respondent shall enroll in and complete a continuing education program in the area of anger management. This continuing education program is subject to the Director of OPMC's prior written approval and shall be completed within the first year of the probation period.
11. Respondent shall comply with this Consent Order and all its terms, and shall bear all associated compliance costs. Upon receiving evidence of noncompliance with, or a violation of, these terms, the Director of OPMC and/or the Board may initiate a violation of probation proceeding, and/or any other such proceeding authorized by law, against Respondent.
