STIPULATION AND APPLICATION FOR VACATING AN INTERIM ORDER OF CONDITIONS PURSUANT TO N.Y. PUB. HEALTH LAW § 230

ZHANNA TSUKERMAN, M.D., represents that all of the following statements are true:

That on or about 6/15/09, I was licensed to practice as a physician in the State of New York and Issued License No. 253527 by the New York State Education Department.

My current address is a filliated with the following hospitals and/or facilities: Coney Island Hospital.

I agree to the State Board for Professional Medical Conduct (Board) vacating the Interim Order of Conditions, Order #19-088, that previously restricted my practice of medicine in New York State (performing invasive procedures), based on the understanding that the Director of the Office of Professional Medical Conduct (OPMC) has determined and is satisfied that all infection prevention and control hazards have been adequately and appropriately mitigated and that patients can be tested and treated safely.
