#### RAYMOND DONALD REYNOLDS, M.D., says:

On or about February 15, 1961, I was licensed to practice medicine as a physician in the State of New York having been issued License No. 085678 by the New York State Education Department. I currently reside at 15485 Ventura Blvd., Sherman Oaks, CA 91403.

I am not currently registered with the New York State Education Department to practice as a physician in the State of New York.

I understand that the New York State Board for Professional Medical Conduct has charged me with two (2) specifications of professional misconduct as set forth in the Statement of Charges, annexed hereto, made a part hereof, and marked as Exhibit "A."

I am applying to the State Board for Professional Medical Conduct for an agreement to allow me to surrender my license as a physician in the State of New York and request that the Board issue this Surrender Order.

I, hereby, agree not to contest the two (2) specifications set forth in the Statement of Charges (Exhibit A).

I understand that in the event that this proposed agreement is not granted by the State Board for Professional Medical Conduct, nothing contained herein shall be binding upon me or construed to be an admission of any act of misconduct alleged or charged against me, such proposed agreement shall not be used against me in any way, and shall be kept in strict

confidence during the pendency of the professional misconduct disciplinary proceeding; and such denial by the State Board for Professional Medical Conduct shall be made without prejudice to the continuance of any disciplinary proceeding and the final determination by a Committee on Professional Medical Conduct pursuant to the provisions of the Public Health Law.

I agree that, in the event the Board grants my Application, as set forth herein, an order of the Chairperson of the Board shall be issued in accordance with same upon issuance by the Board, which may be accomplished by mailing, by first class mail, a copy of the Order to me at the address set forth above or to my attorney or upon transmission via facsimile to me or my attorney, whichever is first.

I am making this agreement of my own free will and accord and not under duress, compulsion or restraint of any kind of manner.

**CHARGES** 

**RAYMOND DONALD REYNOLDS, M.D.**, the Respondent, was authorized to practice medicine in New York state on February 15, 1961, by the issuance of license number 085678 by the New York State Education Department.

#### **FACTUAL ALLEGATIONS**

- A. On or about March 22, 2002, the Division of Medical Quality, Medical Board of California, Department of Consumer Affairs, (hereinafter "California Board") by a Decision (hereinafter "California Decision"), revoked Respondent's Physician and Surgeon's Certificate, and ordered him to pay \$12,156.84 investigative costs, based on obtaining controlled substances by fraud/deceit, false statements in a prescription, gross negligence, use of a false name or address in a controlled substance prescription, prescribing controlled substances not for legitimate and medical purpose in the course of practice, issuance of a false prescription, obtaining or possessing an unauthorized prescription, obtaining controlled substance by nonconforming prescription, controlled substance obtained or possessed by nonconforming prescription, dishonesty, and failure to maintain adequate and accurate medical records.
- B. The conduct resulting in the California Board disciplinary action against Respondent would constitutes misconduct under the laws of New York state, pursuant to the following sections of New York state Law:
  - 1. New York Education Law §6530(2) (practicing the profession fraudulently);
  - New York Education Law §6530(3) (negligence on more than one occasion);
  - New York Education Law §6530(4) (gross negligence);
  - 4. New York Education Law §6530(20) (moral unfitness);

- 5. New York Education Law §6530(32 (inadequate recordkeeping); and/or
- 6. New York Education Law §6530(35) (ordering of excessive treatment not warranted by the condition of the patient).

# SPECIFICATIONS FIRST SPECIFICATION

Respondent violated New York Education Law §6530(9)(b) having been found guilty of improper professional practice or professional misconduct by a duly authorized professional disciplinary agency of another state where the conduct upon which the finding was based would, if committed in New York state, constitute professional misconduct under the laws of New York state, in that Petitioner charges:

1. The facts in Paragraphs A and/or B.

#### SECOND SPECIFICATION

Respondent violated New York Education Law §6530(9)(d) by having his license to practice medicine revoked or having other disciplinary action taken by a duly authorized professional disciplinary agency of another state, where the conduct resulting in the revocation or other disciplinary action would, if committed in New York state, constitute professional misconduct under the laws of New York state, in that Petitioner charges:

2. The facts in Paragraphs A and/or B.
