On or about July 28, 1969, I was licensed to practice medicine as a physician in the State of New York having been issued License No. 104229 by the New York State Education Department.

Burbridge Road SE, Cumberland, MD 21502, and I will advise the Director of the Office of Professional Medical Conduct of any change of my address.

I understand that I have been charged with two specifications of professional misconduct as set forth in the Statement of Charges, annexed hereto, made a part hereof, and marked as Exhibit "A".

I am applying to the State Board for Professional Medical Conduct for permission to surrender my license as a physician in the State of New York on the grounds that I do not contest the two specifications in full satisfaction of the Statement of Charges.

I hereby make this application to the State Board for Professional Medical Conduct and request that it be granted.

I understand that, in the event that the application is not granted by the State Board for Professional Medical Conduct, nothing contained herein shall be binding upon me or construed to be an admission of any act of misconduct alleged or charged against me, such application shall not be used against me in any way, and shall be kept in strict confidence during the pendency of the professional misconduct disciplinary proceeding; and such denial by the State Board for Professional Medical Conduct shall be made without prejudice to the continuance of any disciplinary proceeding and the final determination by a Committee on Professional Medical Conduct pursuant to the provisions of the Public Health Law.

I agree that, in the event the State Board for Professional Medical Conduct grants my application, an order shall be issued striking my name from the roster of physicians in the State of New York without further notice to me.

I am making this Application of my own free will and accord and not under duress, compulsion or restraint of any kind or manner. In consideration of the value to me of the acceptance by the Board of this Application, allowing me to resolve this matter without the various risks and burdens of a hearing on the merits, I knowingly waive any right I may have to contest the Surrender Order for which I hereby apply, whether administratively or judicially, and ask that the Application be granted.

STATEMENT OF CHARGES

Jeffrey Goltz, M.D., the Respondent, was authorized to practice medicine in New York State on or about July 28, 1969, by the issuance of license number 104229 by the New York State Education Department.

FACTUAL ALLEGATIONS

A. On or about July 26, 1996, Respondent pled guilty in the United States District Court for the District of Columbia to one felony count of perjury in violation of 18 U.S.C. §1621 and one felony count of tax evasion in violation of 26 U.S.C. §7201, based on the following: On or about December 16, 1991 while testifying as an orthopedic expert witness in Federal Court, Respondent stated that he had qualifications and credentials that he in fact did not have. In addition, from January 1, 1989 through May 4, 1992, Respondent purchased rare books and listed them on his tax return as medical books or patient refunds and made improvements to his residence that he listed as improvements to his medical office. On or about February 25, 1997, Respondent was sentenced to 18 months in prison, three years of supervision upon release, a \$40,000 fine and restitution in the amount of \$1,395,000.

B. On or about June 11, 1997, the Maryland Medical Board revoked Respondent's medical license in that State, based on Respondent's criminal conviction in Federal Court as set forth in Paragraph A, pursuant to Md. Code Ann., Health Occ. §14-404(b).

SPECIFICATION OF CHARGES

FIRST SPECIFICATION CRIMINAL CONVICTION (Federal)

Respondent is charged with committing professional misconduct as defined in N.Y. Educ. Law §6530(9)(a)(ii)(McKinney Supp.1998) by having been convicted of committing an act constituting a crime under federal law as alleged in the facts of the following:

SECOND SPECIFICATION HAVING HAD DISCIPLINARY ACTION TAKEN

Respondent is charged with committing professional misconduct as defined in N.Y. Educ. Law §6530(9)(d)(McKinney Supp. 1998) by having his license to practice medicine revoked, suspended or having other disciplinary action taken, or having his application for a license refused, revoked or suspended or having voluntarily or otherwise surrendered his license after a disciplinary action was instituted by a duly authorized professional disciplinary agency of another state, where the conduct resulting in the revocation, suspension or other disciplinary action involving the license or refusal, revocation or suspension of an application for a license or the

surrender of the license would, if committed in New York State, constitute professional misconduct under the laws of New York State (namely N.Y. Educ. Law §6530(9)(a)(ii)) as alleged in the facts of the following:
