I understand that the New York State Board for Professional Medical Conduct has charged me with two Specifications of professional misconduct.

A copy of the Statement of Charges is annexed hereto, made a part hereof, and marked as Exhibit "A".

I admit guilt to the specifications in full satisfaction of the charges against me. I hereby agree to the penalty that my l; icense will be suspended for a period of one year from the issuance of the Chairperson's order; that the suspension will be stayed, and that during this year I will be on probation subject to the terms annexed hereto as Exhibit B.

I hereby make this Application to the State Board for Professional Medical Conduct (the Board) and request that it be granted.

I understand that, in the event that this Application is not granted by the Board, nothing contained herein shall be binding upon me or construed to be an admission of any act of misconduct alleged or charged against me, such Application shall not be used against me in any way and shall be kept in strict confidence during the pendency of the professional misconduct disciplinary proceeding; and such denial by the Board shall be made without prejudice to the continuance of any disciplinary proceeding and the final determination by the Board pursuant to the provisions of the Public Health Law.

I agree that, in the event the Board grants my Application, as set forth herein, an order of the Chairperson of the Board shall be issued in accordance with same.

I am making this Application of my own free will and accord and not under duress, compulsion or restraint of any kind or manner.



NORBERT SCHACHTER, M.D., the Respondent, was authorized to practice medicine in New York State on March 4, 1970 by the issuance of license number 105511 by the New York State Education Department. The Respondent is not currently registered with the New York State Education Department to practice medicine.

## FIRST SPECIFICATION

A. The Respondent is charged with professional misconduct within the meaning of N.Y. Educ. Law Section 6530(9)(a)(iii) (McKinney Supp. 1993) in that he has been found guilty of committing an act constituting a crime under New Jersey law and which if committed within this state would constitute a crime under New York law.

> On or about February 24, 1988 the Respondent plead guilty to three counts of Tax Evasion pursuant to N.J. Stat Section 54A:2-1, N.J.

> > EXHIBIT "A"

Stat Section 54A:5-1, N.J. Stat. Section 54A:8-1, N.J. Stat Section 54A:9-15A, in that he failed to file gross income tax returns and pay income tax for the years 1982, 1983, and 1984. This conduct if committed in New York would constitute a violation of N.Y. Tax Law Crimes and Forfeitures Section 1801 failure to file a return or report, a misdemeanor, and Section 1802 repeated failure to file, a Class E felony.

Respondent was sentenced to two years probation 150 hours community service, and \$9,000 fine.

#### SECOND SPECIFICATION

B. The Respondent is charged with professional misconduct within the meaning of N.Y. Educ. Law Section 6530(9)(d) in that he had disciplinary action taken against his license by a duly authorized professional disciplinary agency of another state where the conduct resulting in the disciplinary action would if committed in New York State, constitute misconduct under the laws of New York State, in that:

On or about March 25, 1991 the New Jersey State Board of Medical Examiners issued a consent order where in the Respondent acknowledged that he had been convicted of a crime of moral turpitude in violation of N.J. Respondent's New Statutes Section 45:1-21F. Jersey medical license was suspended for three years, of which two months were active, and he received 450 hours of community service. This conduct if committed in New York would constitute violation of N.Y. Educ. Law Section 6530(9)(a)(iii), being convicted of an act constituting a crime under the laws of another jurisdiction which if committed in New York would constitute a crime under New York State law.

# TERMS OF PROBATION

 NORBERT SCHACHTER, M.D., during the period of probation, shall conduct himself in all ways in a manner befitting his professional status, and shall conform fully to the moral and professional standards of conduct imposed by law and by his profession;

That Respondent shall submit written notification to the New York State Department of Health (NYSDOH), addressed to the Director, Office of Professional Medical Conduct, New York State Health Department, Corning Tower Building, 4th Floor, Empire State Plaza Albany, New York 12237 of any employment and practice, of Respondent's residence and telephone number, of any change in Respondent's employment, practice, residence, or telephone number within or without the State of New York;
  - 3. Respondent shall submit written proof from the Division of Professional Licensing Services (DPLS), New York State Education Department (NYSED), that Respondent has paid all registration fees due and owing to the NYSED and Respondent shall cooperate with and submit whatever papers are requested by DPLS in regard to said registration fees, said proof from DPLS to be submitted by Respondent to the New York State Department of Health, addressed to the Director, Office of Professional Medical Conduct, as aforesaid, no later than the first three months of the period of probation;
  - 4. Respondent shall submit written proof to the NYSDOH, addressed to the Director, Office of Professional Medical Conduct, as aforesaid, that 1) Respondent is currently registered with the NYSED, unless Respondent submits written proof that Respondent has advised DPLS, NYSED, that Respondent is not engaging in the practice of Respondent's profession in the State of New York and does not desire to register, and that 2) Respondent has paid any fines which may have previously been imposed upon Respondent by the Board or by the Board of Regents; said proof of the above to be submitted no later than the first two months of the period of probation;
    - Respondent shall comply with all terms, conditions, restrictions, and penalties to which he is subject pursuant to the order of the Board;
    - 6. So long as there is full compliance with every term herein set forth, Respondent may continue to practice his or her aforementioned profession in accordance with the terms of

probation; provided, however, that upon receipt of evidence of noncompliance with, or any violation of these terms, the Director of the Office of Professional Medical Conduct and/or the Board may initiate a violation of probation proceeding and/or such other proceeding against Respondent as may be authorized pursuant to the Public Health Law.
