**AND ORDER** 

**BAHAI BAHADUR SINGH, M.B.B.S.,** representing that all of the following statements are true, deposes and says:

That on or about November 28, 1972, I was licensed to practice as a physician in the State of New York, and issued License No. 114565 by the New York State Education Department.

My current address is 18 Coates Lane, Indiana, PA 15701.

I understand that the New York State Board for Professional Medical Conduct (Board) has charged me with one (1) Specification of professional misconduct, based solely on the Commonwealth of Pennsylvania, Department of State, State Board of Medicine, Consent Agreement and Order, dated November 28, 2006.

A copy of the Statement of Charges, marked as Exhibit "A", is attached to and part of this Consent Agreement.

New York State has offered to settle this matter with a Censure and Reprimand and a \$5,000.00 fine.

I have not practiced medicine in the State of New York since 1974, and I do not intend to return to the practice of medicine in the State of New York.

I do not, therefore, contest Factual Allegations A and B (2) and the Specification, in full satisfaction of the charges against me, and agree to the following penalty:

I shall never activate my registration to practice medicine in New York state or seek to reapply for a license to practice medicine in New York state.

I further agree that the Consent Order shall impose the following conditions:

That Respondent shall cooperate fully with the Office of Professional Medical Conduct (OPMC) in its administration and enforcement of this Consent Order and in its investigations of matters concerning Respondent. Respondent shall respond in a timely manner to all OPMC requests for written periodic verification of Respondent's compliance with this Consent Order. Respondent shall meet with a person designated by the Director of OPMC, as directed. Respondent shall respond promptly and provide all documents and information within Respondent's control, as directed. This condition shall take effect upon the Board's issuance of the Consent Order and will continue so long as Respondent remains licensed in New York State.

I stipulate that my failure to comply with any conditions of this Consent Order shall constitute misconduct as defined by New York Education Law § 6530(29).

I agree that, if I am charged with professional misconduct in future, this Consent Agreement and Order shall be admitted into evidence in that proceeding.

I ask the Board to adopt this Consent Agreement.

I understand that if the Board does not adopt this Consent Agreement, none of its terms shall bind me or constitute an admission of any of the acts of alleged misconduct; this Consent Agreement shall not be used against me in any way and shall be kept in strict confidence; and the Board's denial shall be without prejudice to the pending disciplinary proceeding and the Board's final determination pursuant to New York Public Health Law.

I agree that, if the Board adopts this Consent Agreement, the Chair of the Board shall issue a Consent Order in accordance with its terms. I agree that this Consent Order shall take effect upon its issuance by the Board, either by mailing of a copy of the Consent Order by first class mail to me at the address in this Consent Agreement, or to my attorney by certified mail, or upon facsimile transmission to me or my attorney, whichever is first. The Consent Order, this agreement, and all attached Exhibits shall be public documents, with only patient identities, if any, redacted. As public documents, they may be posted on the Department's website.

I stipulate that the proposed sanction and Consent Order are authorized by New York
Public Health Law §§ 230 and 230-a, and that the Board and OPMC have the requisite powers
to carry out all included terms. I ask the Board to adopt this Consent Agreement of my own free
will and not under duress, compulsion or restraint. In consideration of the value to me of the
Board's adoption of this Consent Agreement, allowing me to resolve this metter without the
various risks and burdens of a hearing on the ments. I knowingly waive my right to contest the
Consent Order for which I apply, whether administratively or judicially, I agree to be bound by
the Consent Order, and I ask that the Board adopt this Consent Agreement.

I understand and agree that the attorney for the Department, the Director of OPMC and the Chair of the Board each retain complete discretion either to enter into the proposed agreement and Consent Order, based upon my application, or to decline to do so. I further understand and agree that no prior or separate written or oral communication can limit that discretion.

CHARGES

**BAJAI BAHADUR SINGH, M.B.B.S.,** Respondent, was authorized to practice medicine in New York state on November 28, 1972, by the issuance of license number 114565 by the New York State Education Department.

## **FACTUAL ALLEGATIONS**

- A. On or about November 28, 2006, the Commonwealth of Pennsylvania, Department of State, State Board of Medicine, (hereinafter "Pennsylvania Board"), by a Consent Agreement and Order (hereinafter "Pennsylvania Order"), PUBLICLY REPRIMANDED Respondent and required him to complete twelve (12) hours of REMDEIAL EDUCATION in the evaluation and treatment of diabetes with emphasis on inpatient care of diabetic patients, based on departing from and/or failing to conform to quality standards and/or care in the profession.
- B. The conduct resulting in the Pennsylvania Board disciplinary action against Respondent would constitute misconduct under the laws of New York state, pursuant to the following sections of New York state law:
  - 1. New York Education Law §6530(4) (gross negligence); and/or
  - 2. New York Education Law §6530(6) (gross incompetence).

## **SPECIFICATION**

Respondent violated New York Education Law §6530(9)(d) by having disciplinary action taken by a duly authorized professional disciplinary agency of another state, where the conduct resulting in the disciplinary action would, if committed in New York state, constituted professional misconduct under the laws of New York state, in that Petitioner charges:

1. The facts in Paragraphs A and/or B.
