
ORDERED, that the application and the provisions thereof are hereby adopted; it is further



I understand that, in the event that the application is not granted by the State Board for Professional Medical Conduct, nothing contained herein shall be binding upon me or construed to be an admission of any act of misconduct alleged or charged against me, such application shall not be used against me in any way, and shall be kept in strict confidence during the pendency of the professional misconduct disciplinary proceeding; and such denial by the State Board for Professional Medical Conduct shall be made without prejudice to the continuance of any disciplinary proceeding and the final determination by a Committee on Professional Medical Conduct pursuant to the provisions of the Public Health Law.

I agree that, in the event the State Board for Professional Medical Conduct grants my application, an order shall be issued striking my name from the roster of physicians in the State of New York without further notice to me.



STATEMENT
OF
CHARGES

RAJGOPAL SESHADRI, M.D., the Respondent, was authorized to practice medicine in New York State on or about March 19, 1973, by the issuance of license number 115745 by the New York State Education Department.

FACTUAL ALLEGATIONS

- A. On or about March 26 1996, Respondent was convicted after trial in the Supreme Court of the State of New York, County of Nassau, of Grand Larceny in the Third Degree, a class D felony, in violation of Section 155.35 of the Penal Law. From in or about May 1990 to on or about December 31, 1993, in Nassau County, Respondent, acting in concert with others, intentionally stole property valued in excess of \$3,000 by submitting and causing to be submitted to Computer Sciences, Inc, a fiscal agent of New York State under the Medicaid program, numerous claims which represented that therapists of the Roosevelt Community Mental Health Center had provided therapy services to various Medicaid recipients when Respondent knew that such services had not been provided. In reliance upon the false representations, the State of New York, through its fiscal agent, paid the Roosevelt Community Mental Health Center in excess of \$200,000 to which it was not entitled. On or about June 12, 1996, Respondent was sentenced to five years probation, restitution of \$30,448.77, a \$60,897.54 fine, and a \$5 crime victim assistance fee.

SPECIFICATION OF CHARGES

CRIMINAL CONVICTION (N.Y.S.)

Respondent is charged with committing professional misconduct as defined in N.Y. Educ. Law §6530(9)(a)(i)(McKinney Supp. 1997) by having been convicted of committing an act constituting a crime under New York state law, as alleged in the following:
