YET MIN LIN, M.D. a/k/a TOMMY Y. LIN, M.D., being duly sworn, deposes and says:

On or about November 5, 1976, I was licensed to practice as a physician in the State of New York having been issued License No. 129198 by the New York State Education Department.

I am not currently registered to practice as a physician in the State of New York; I was last registered prior to December 31, 1988. I currently reside at Lo-Tung, Taiwan, Republic of China.

I understand that I have been charged with one specification of professional misconduct as set forth in the Statement of Charges, annexed hereto, made a part hereof, and marked as Exhibit "A". I am applying to the State Board for Professional Medical Conduct for permission to surrender my license as a physician in the State of New York on the grounds that I agree not to contest the specification of professional misconduct set forth in the charges.

I hereby make this application to the State Board for Professional Medical Conduct and request that it be granted.

I understand that, in the event that the application is not granted by the State Board for Professional Medical Conduct, nothing contained herein shall be binding upon me or construed to be an admission of any act of misconduct alleged or charged against me, such application shall not be used against me in any way, and shall be kept in strict confidence during the pendency of the professional misconduct disciplinary proceeding; and such denial by the State Board for Professional Medical Conduct shall be made without prejudice to the continuance of any disciplinary proceeding and the final determination by a Committee on Professional Medical Conduct pursuant to the provisions of the Public Health Law.

I agree that in the event the State Board for Professional Medical Conduct grants my application, an order shall be issued

YET MIN LIN a/k/a TOMMY Y. LIN, the Respondent, was authorized to practice medicine in New York State on November 5, 1976 by the issuance of license number 129198 by the New York State Education Department. The Respondent is not currently registered to practice medicine. Respondent was last registered to practice medicine in the State of New York prior to December 1978. Upon information and belief, Respondent currently resides at Lo-Tung, Taiwan, Republic of China.

## SPECIFICATION

## HAVING DISCIPLINARY ACTION TAKEN AFTER DISCIPLINARY ACTION WAS INSTITUTED BY ANOTHER STATE

Respondent is charged with professional misconduct within the meaning of N.Y. Educ. Law Sec. 6530(9)(d) (McKinney Supp. 1994) in that he surrendered his license to practice medicine after a disciplinary action was instituted by a duly authorized professional disciplinary agency of another state, where the conduct resulting in the disciplinary action involving the license would, if committed in New York State, constitute professional misconduct under the laws of New York State, specifically,

On or about February 6, 1992, the Department of Professional Regulation of the State of Illinois (Illinois DPR) issued an Order approving a Stipulation and Recommendation for Settlement and ordering Respondent to surrender his license to practice medicine in the State of Illinois.

The Stipulation for Settlement was predicated on a Complaint filed by the Illinos DPR on September 26, 1990 and an Amended Complaint similarly filed on November 19, 1990, alleging that Respondent engaged in conduct including negligence with respect to his care of three patients upon whom he performed intraocular surgery in violation of Ill. Rev. Statutes, Ch. 111, Secs. 4433, 4400-22(13); incompetence on more than one occasion with respect to his care of three patients upon whom he performed intraocular surgery in violation of Ill. Rev. Statutes, Ch. 111, Sec. 4433(25); altering medical records with respect to five patients in violation of Ill. Rev. Statutes, Ch. 111, Sec. 4433(21); and willfully making or filing a false record or report in violation of Ill. Rev. Statutes, Ch. 111, Sec. 4433(21).

The conduct resulting in the disciplinary action involving Respondent's Illinois medical license if committed in New York State, would have constituted professional misconduct under New York Educ. Law Section 6530 (McKinney Supp. 1994), as follows: Sec. 6530(3), <u>i.e.</u>, practicing the profession with negligence on more than one occasion; Sec. 6530(5), <u>i.e.</u>, incompetence on more than one occasion; Sec. 6530(21), <u>i.e.</u>, willfully making or filing a false report; and Sec. 6530(32) failure to maintain a record for each patient which accurately reflects the evaluation and treatment of the patient.
