JOSEPH WYNN WESLEY, M.D., says:

On or about April 7, 1978, I was licensed to practice medicine as a physician in the State of New York having been issued License No. 134157 by the New York State Education Department. I currently reside at 246 North Franklin Turnpike, Ramsey, NJ 07446.

I am not currently registered with the New York State Education Department to practice as a physician in the State of New York.

I understand that the New York State Board for Professional Medical Conduct has charged me with two (2) specifications of professional misconduct as set forth in the Statement of Charges, annexed hereto, made a part hereof, and marked as Exhibit "A."

I am applying to the State Board for Professional Medical Conduct for an agreement to allow me to surrender my license as a physician in the State of New York and request that the Board issue this Surrender Order.

I, hereby, agree not to contest the two (2) specifications set forth in the Statement of Charges (Exhibit A).

I understand that in the event that this proposed agreement is not granted by the State Board for Professional Medical Conduct, nothing contained herein shall be binding upon me or construed to be an admission of any act of misconduct alleged or charged against me, such proposed agreement shall not be used against me in any way, and shall be kept in strict confidence during the pendency of the professional misconduct disciplinary proceeding; and

STATEMENT

CHARGES

JOSEPH WYNN WESLEY, M.D., the Respondent, was authorized to practice medicine in New York state on April 7, 1978, by the issuance of license number 134157 by the New York State Education Department.

FACTUAL ALLEGATIONS

A. On or about February 13, 2002, the New Jersey State Board of Medical Examiners (hereinafter "New Jersey Board"), by a Final Decision and Order (hereinafter "New Jersey Order"), revoked Respondent's license to practice medicine and surgery, prohibited him from applying for reinstatement for two (2) years, and assessed a \$5,000.00 penalty, based on failure to register for two (2) years, prescribing drugs requiring a DEA without a valid DEA license, and failure to respond candidly while under oath to questions on his registration application.

B. The conduct resulting in the New Jersey Board disciplinary action against Respondent would constitute misconduct under the laws of New York state, pursuant to the following sections of New York state Law:

1. New York Education Law §6530(2) (practicing the profession fraudulently);

2. New York Education Law §6530(12) (practicing the profession while the license is inactive or willfully failing to register); and/or

3. New York Education Law §6530(16) (failure to comply with federal, state, or local laws, rules, or regulations governing the practice of medicine).

SPECIFICATIONS FIRST SPECIFICATION

Respondent violated New York Education Law §6530(9)(b) by having been found guilty of improper professional practice or professional misconduct by a duly authorized professional disciplinary agency of another state where the conduct upon which the finding was based would, if committed in New York state, constitute professional misconduct under the laws of New York state, in that Petitioner charges:

1. The facts in paragraphs A and/or B.

SECOND SPECIFICATION

Respondent violated New York Education Law §6530(9)(d) by having had his license to practice medicine revoked or having other disciplinary action taken by a duly authorized professional disciplinary agency of another state, where the conduct resulting in the revocation or other disciplinary action would, if committed in New York state, constitute professional misconduct under the laws New York state, in that Petitioner charges:

2. The facts in paragraphs A and/or B.
