MODIFICATION ORDER

HARRY B. LESCH, M.D., (Respondent) being duly sworn deposes and says:

That on or about February 9, 1979, I was licensed to practice as a physician in the State of New York, having been issued License No. 137313 by the New York State Education Department.

My current address is 2934 "H" St. / EUREKA, CA 95501.

I am currently subject to Consent Order BPMC No. 02-232, (hereinafter "Original Order"), annexed hereto, made a part, hereof, and marked as Exhibit 1, that was issued on October 14, 2002.

I apply, hereby, to the State Board for Professional Medical Conduct for a Modification Order (hereinafter "Modification Order"), modifying the Original Order, as follows: to delete the paragraph in the Original Order that states:

" That, except during periods of actual suspension, I shall maintain current registration of my license with the New York State Education Department Division of Professional Licensing Services, and pay all registration fees. This condition shall be in effect beginning thirty days after the effective date of the Consent Order and will continue while Respondent possesses his license; and"

substituting therefore:

" The five (5) year suspension of my New York State license to practice medicine and probation is terminated, hereby, based on the Division of Medical Quality, Medical Board of California, Department of Consumer Affairs, March 15, 2005, Decision, terminating my probation and fully restoring my license to practice medicine.

and:

" I no longer wish to practice medicine in New York State. Since New York State has no provision for a doctor to be placed on an inactive status or have an inactive license to practice medicine under these circumstances, I agree, hereby, to never activate my registration to practice medicine in New York State or seek to reapply for a new license to practice medicine in New York State. I make this decision of my own free will and not as a result of any disciplinary proceedings. In fact, there are no disciplinary proceedings pending against me in New York State. Further, the State of New York will not charge me any registration fees and will not initiate any disciplinary proceedings against me for failing to maintain an active registration."


The Modification Order to be issued will not constitute a new disciplinary action against me, but will substitute the proposed language for the above described language in the Original Order.

I make this Application of my own free will and accord and not under duress, compulsion or restraint, and seek the anticipated benefit of the requested Modification. In consideration of the value to me of the acceptance of the Board of this Application, I knowingly waive the right to contest the Original Order or the Modification Order for which I apply, whether administratively or judicially, and ask that the Board grant this Application.

I understand and agree that the attorney for the Bureau of Professional Medical Conduct, the Director of the Office of Professional Medical Conduct, and the Chair of the State Board for Professional Medical Conduct each retain complete discretion either to enter into the proposed Agreement and Modification Order, based upon my application, or to decline to do so. I further understand and agree that no prior or separate written or oral communication can limit that discretion.



HARRY B. LESCH, M.D., (Respondent) states:

That on or about February 9, 1979, I was licensed to practice as a physician in the State of New York, having been issued License No. 137313 by the New York State Education Department.

My current address is 4058 "D" Street, Eureka, CA 95503, and I will advise the Director of the Office of Professional Medical Conduct of any change of my address within thirty (30) days thereof.

I understand that the New York State Board for Professional Medical Conduct has charged me with one (1) specification of professional misconduct.

A copy of the Statement of Charges is annexed hereto, made a part hereof, and marked as Exhibit A.

I do not contest the one (1) specification, in full satisfaction of the charges against me. I, hereby, agree to the following penalty:

Five (5) year suspension of my New York state license to practice medicine, said suspension stayed contingent upon my successful continued participation in the five (5) years probation as set forth in the Stipulated Settlement and Disciplinary Order that was submitted before

the Division of Medical Quality, Medical Board of California, Department of Consumer Affairs, State of California, that is annexed hereto, made a part hereof, and marked as Exhibit "B." That I must satisfy all requirements of the Disciplinary Order as set forth in Exhibit "B." That upon successful completion of the probation as provided in the Stipulated Settlement and Disciplinary Order annexed hereto as Exhibit "B," and my license to practice medicine in the State of California is fully restored without conditions, my license to practice medicine in the State of New York shall be fully restored.

I further agree that the Consent Order for which I, hereby, apply shall impose the following conditions:

That, except during periods of actual suspension, I shall maintain current registration of my license with the New York State Education Department Division of Professional Licensing Services, and pay all registration fees. This condition shall be in effect beginning thirty days after the effective date of the Consent Order and will continue while Respondent possesses his license; and

That I shall fully cooperate in every respect with the Office of Professional Medical Conduct (OPMC) in its administration and enforcement of this Order and in its investigation of all matters regarding Respondent. I shall respond in a timely manner to each and every request by OPMC to provide written periodic verification of Respondent's compliance with the terms of this Order. I shall meet with a person designated by the Director of OPMC as directed. I shall respond promptly and provide any and all documents and information within my control upon the direction of OPMC. This condition shall be in effect beginning upon the effective date of the Consent Order and will continue while I possess my license.

I, hereby, stipulate that any failure by me to comply with such conditions shall constitute misconduct as defined by New York State Education Law §6530(29).

I agree that in the event I am charged with professional misconduct in the future, this agreement and order shall be admitted into evidence in that proceeding.


I, hereby, make this application to the State Board for Professional Medical Conduct (the Board) and request that it be granted.

I understand that, in the event that this application is not granted by the Board, nothing contained herein shall be binding upon me or construed to be an admission of any act of misconduct alleged or charged against me, such application shall not be used against me in any way and shall be kept in strict confidence during the pendency of the professional misconduct disciplinary proceeding; and such denial by the Board shall be made without prejudice to the continuance of any disciplinary proceeding and the final determination by the Board pursuant to the provisions of the Public Health Law.

I agree that, in the event the Board grants my application, as set forth herein, an order of the Chairperson of the Board shall be issued in accordance with same. I agree that such order shall be effective upon issuance by the Board, which may be accomplished by mailing, by first class mail, a copy of the Consent Order to me at the address set forth in this agreement, or to my attorney, or upon transmission via facsimile to me or my attorney, whichever is earliest.

I am making this application of my own free will and accord and not under duress, compulsion or restraint of any kind or manner. STIPULATED SETTLEMENT AND
DISCIPLINARY ORDER

IT IS HEREBY STIPULATED AND AGREED by and between the parties to the above-entitled proceedings that the following matters are true:

PARTIES

1. Ron Joseph (Complainant) is the Executive Director of the Medical Board of California. He brought this action solely in his official capacity and is represented in this matter by Bill Lockyer, Attorney General of the State of California, by Lawrence A. Mercer, Deputy Attorney General.

2. Respondent Harry B. Lesch, M.D. (Respondent) is represented in this proceeding by attorney Michael Morrison, Esq., whose address is Janssen, Malloy, Needham, Morrison & Reinholtsen, 730 Fifth Street, Eureka, CA 95501.

3. On or about June 30, 2002, the Medical Board of California issued



1 Physician's and Surgeon's Certificate No. G-22275 to Harry B. Lesch, M.D., and said
2 Physician's and Surgeon's Certificate was in full force and effect at all times relevant to the
3 charges.

4 JURISDICTION

5 4. Accusation No. 12-1999-105366 was filed before the Division of Medical
6 Quality, Medical Board of California of the Department of Consumer Affairs, (Division), and is
7 currently pending against Respondent. The Accusation, together with all other statutorily
8 required documents were properly served on Respondent on January 4, 2001, and Respondent
9 timely filed his Notice of Defense contesting the Accusation. A copy of Accusation No.
10 12-1999-105366 is attached as Exhibit A and incorporated herein by reference.

11 ADVISEMENT AND WAIVERS

12 5. Respondent has carefully read, fully discussed with counsel, and
13 understands the charges and allegations in Accusation No. 12-1999-105366. Respondent has
14 also carefully read, fully discussed with counsel, and understands the effects of this Stipulated
15 Settlement and Disciplinary Order.

16 6. Respondent is fully aware of his legal rights in this matter, including the
17 right to a hearing on the charges and allegations in the Accusation; the right to be represented by
18 counsel at his own expense; the right to confront and cross-examine the witnesses against him;
19 the right to present evidence and to testify on his own behalf; the right to the issuance of
20 subpoenas to compel the attendance of witnesses and the production of documents; the right to
21 reconsideration and court review of an adverse decision; and all other rights accorded by the
22 California Administrative Procedure Act and other applicable laws.

23 7. Respondent voluntarily, knowingly, and intelligently waives and gives up
24 each and every right set forth above.

25 CULPABILITY

26 8. Respondent understands and agrees that the charges and allegations in
27 Accusation No. 12-1999-105366, if proven at a hearing, constitute cause for imposing discipline
28 upon his license to practice medicine in the State of California.

1 stayed and Respondent is placed on probation for five (5) years on the following terms and
2 conditions.

3 Within 15 days after the effective date of this decision the respondent shall
4 provide the Division, or its designee, proof of service that Respondent has served a true copy of
5 this decision on the Chief of Staff or the Chief Executive Officer at every hospital where
6 privileges or membership are extended to Respondent or at any other facility where Respondent
7 engages in the practice of medicine and on the Chief Executive Officer at every insurance carrier
8 where malpractice insurance coverage is extended to Respondent.

9 1. PREScribing PRACTICES COURSE Within six months of the
10 effective date of this decision, Respondent shall enroll in a course in Prescribing Practices,
11 approved in advance by the Division or its designee, and shall successfully complete the course
12 during the first year of probation. The Prescribing Practices Course administered by the
13 University of California, San Diego, Physician Assessment and Clinical Education Program
14 (PACE), shall be deemed approved by the Division in satisfaction of this requirement.

15 2. ETHICS COURSE Within six months of the effective date of this
16 decision, Respondent shall enroll in a course in Ethics approved in advance by the Division or its
17 designee, and shall successfully complete the course during the first year of probation.

18 3. OBEY ALL LAWS Respondent shall obey all federal, state and local
19 laws, all rules governing the practice of medicine in California, and remain in full compliance
20 with any court ordered criminal probation, payments and other orders.

21 4. QUARTERLY REPORTS Respondent shall submit quarterly
22 declarations under penalty of perjury on forms provided by the Division, stating whether there
23 has been compliance with all the conditions of probation.

24 5. PROBATION SURVEILLANCE PROGRAM COMPLIANCE
25 Respondent shall comply with the Division's probation surveillance program. Respondent shall,
26 at all times, keep the Division informed of his business and residence addresses which shall both
27 serve as addresses of record. Changes of such addresses shall be immediately communicated in
28 writing to the Division. Under no circumstances shall a post office box serve as an address of

1 record, except as allowed by Business and Professions Code section 2021(b).

2 Respondent shall, at all times, maintain a current and renewed physician's and
3 surgeon's license.

4 Respondent shall also immediately inform the Division, in writing, of any travel
5 to any areas outside the jurisdiction of California which lasts, or is contemplated to last, more
6 than thirty (30) days.

7 6. INTERVIEW WITH THE DIVISION, ITS DESIGNEE OR ITS
8 DESIGNATED PHYSICIAN(S) Respondent shall appear in person for interviews with the
9 Division, its designee or its designated physician(s) upon request at various intervals and with
10 reasonable notice.

11 7. TOLLING FOR OUT-OF-STATE PRACTICE, RESIDENCE OR IN-
12 STATE NON-PRACTICE In the event Respondent should leave California to reside or to
13 practice outside the State or for any reason should Respondent stop practicing medicine in
14 California, Respondent shall notify the Division or its designee in writing within ten (10) days of
15 the dates of departure and return or the dates of non-practice within California. Non-practice is
16 defined as any period of time exceeding thirty (30) days in which Respondent is not engaging in
17 any activities defined in Sections 2051 and 2052 of the Business and Professions Code. All time
18 spent in an intensive training program approved by the Division or its designee shall be
19 considered as time spent in the practice of medicine. A Board-ordered suspension of practice
20 shall not be considered as a period of non-practice. Periods of temporary or permanent residence
21 or practice outside California or of non-practice within California, as defined in this condition,
22 will not apply to the reduction of the probationary order.

23 8. COMPLETION OF PROBATION Upon successful completion of
24 probation, Respondent's certificate shall be fully restored:

25 9. VIOLATION OF PROBATION If Respondent violates probation in any
26 respect, the Division, after giving Respondent notice and the opportunity to be heard, may revoke
27 probation and carry out the disciplinary order that was stayed. If an accusation or petition to
28 revoke probation is filed against Respondent during probation, the Division shall have continuing

1 jurisdiction until the matter is final, and the period of probation shall be extended until the matter
2 is final.

3 10. COST RECOVERY The Respondent is hereby ordered to reimburse the
4 Division the amount of \$2,947.00 payment due for costs. Respondent shall pay \$1,000.00 within
5 one year of the effective date of this decision for its costs incurred in this matter. He shall pay
6 \$1000.00 before the end of his second year of probation and shall pay the balance of \$947.00
7 prior to the end of his third year of probation. Failure to reimburse the Division's cost of
8 investigation and prosecution shall constitute a violation of the probation order. The filing of
9 bankruptcy by the Respondent shall not relieve the Respondent of his responsibility to reimburse
10 the Division for these costs.

11 11. PROBATION COSTS Respondent shall pay the costs associated with
12 probation monitoring each and every year of probation, as designated by the Division, which are
13 currently set at \$2,488.00, but may be adjusted on an annual basis. Such costs shall be payable
14 to the Division of Medical Quality and delivered to the designated probation surveillance
15 monitor no later than October 1st of each calendar year. Failure to pay costs within 30 days of the
16 due date shall constitute a violation of probation.

17 12. LICENSE SURRENDER Following the effective date of this decision, if
18 Respondent ceases practicing due to retirement, health reasons or is otherwise unable to satisfy
19 the terms and conditions of probation, Respondent may voluntarily tender his certificate to the
20 Board. The Division reserves the right to evaluate the Respondent's request and to exercise its
21 discretion whether to grant the request, or to take any other action deemed appropriate and
22 reasonable under the circumstances. Upon formal acceptance of the tendered license,
23 Respondent will not longer be subject to the terms and conditions of probation.



21 1. Ron Joseph ("Complainant") brings this Accusation solely in his official
22 capacity as the Executive Director of the Medical Board of California, Department of Consumer
23 Affairs.

24 2. On or about April 21, 1971, the Medical Board of California issued
25 Physician's and Surgeon's Certificate Number G-22275 to Harry B. Lesch, M.D. ("Respondent").
26 The Physician's and Surgeon's Certificate was in full force and effect at all times relevant to the
27 charges brought herein and will expire on June 30, 2002, unless renewed.

JURISDICTION

1
2 3. This Accusation is brought before the Division of Medical Quality,
3 Medical Board of California ("Division"), under the authority of the following provisions of
4 law:

5 4. Section 2227 of the Business and Professions Code¹ ("Code") provides
6 that a licensee who is found guilty under the Medical Practice Act may have his or her license
7 revoked, suspended for a period not to exceed one year, placed on probation and required to pay
8 the costs of probation monitoring, or such other action taken in relation to discipline as the
9 Division deems proper.

10 5. Section 2234 of the Code states:

11 "The Division of Medical Quality shall take action against any licensee who is
12 charged with unprofessional conduct. In addition to other provisions of this article,
13 unprofessional conduct includes, but is not limited to, the following:

14 "(a) Violating or attempting to violate, directly or indirectly, or assisting in or
15 abetting the violation of, or conspiring to violate, any provision of this
16 chapter [Chapter 5, the Medical Practice Act].

17 "(b) Gross negligence.

18 "(c) Repeated negligent acts.

19 "(d) Incompetence."

20 6. Section 725 of the Code provides that repeated acts of clearly excessive
21 prescribing or administering of drugs or treatment, repeated acts of clearly excessive use of
22 diagnostic or treatment facilities as determined by the standard of the community of licensees is
23 unprofessional conduct.

1. All statutory references are to the Business and Professions Code unless otherwise specified.

1 13. Klonopin is a trade name for clonazepam, an anticonvulsant of the
2 benzodiazepine class of drugs. It is a dangerous drug as defined in section 4022 of the Code, a
3 Schedule IV controlled substance as defined by section 11057 of the Health and Safety Code,
4 and a Schedule IV controlled substance as defined by Section 1308.14 of Title 21 of the Code of
5 Federal Regulations. It produces central nervous system depression and should be used with
6 caution with other central nervous system depressant drugs.

7 14. Lithobid is a trade name for lithium carbonate used in the treatment of
8 manic episodes of manic depressive illness. It is a dangerous drug as defined in section 4022 of
9 the Code.

10 15. Neurontin (gabapentin capsules) is used in the treatment of partial
11 seizures. It is a dangerous drug as defined in section 4022 of the Code.

12 16. Nortriptyline Hydrochloride (also known by the trade name Pamelor), a
13 tricyclic antidepressant, is a dangerous drug within the meaning of Business and Professions
14 Code section 4022.

15 17. Trazodone Hydrochloride is an antidepressant and is a dangerous drug
16 with the meaning of Business and Professions Code section 4022.

17 18. Welbutrin is a trade name for bupropion hydrochloride, an antidepressant
18 of the aminoketone class. It is a dangerous drug within the meaning of Business and Professions
19 Code section 4022.

20 19. Xanax is a trade name for alprazolam tablets. Alprazolam is used for the
21 management of anxiety disorders or for the short-term relief of the symptoms of anxiety. It is a
22 dangerous drug as defined in section 4022 of the Code, a Schedule IV controlled substance and
23 narcotic as defined by section 11057, subdivision (d) of the Health and Safety Code, and a
24 Schedule IV controlled substance as defined by Section 1308.14 (c) of Title 21 of the Code of
25 Federal Regulations.

26 20. Zoloft is a trade name for sertraline hydrochloride, an antidepressant. It is a
27 dangerous drug as defined by section 4022 of the Code.

1 FIRST CAUSE FOR DISCIPLINE

2 (Inappropriate Prescribing and/or Failure to Maintain Records)

3 21. The conduct herein described occurred while respondent was in active
4 practice as a physician and surgeon specializing in psychiatry in Mendocino and Humboldt
5 Counties, California.

6 22. Respondent is subject to disciplinary action under section 2234 of the
7 Code through sections 725 and/or 2242(a) and/or through section 2266 of the Code in that the
8 respondent inappropriately and excessively prescribed controlled substances and dangerous drugs
9 to his wife for several years, and failed to maintain medical or drug records. The circumstances
10 are as follows:

11 A. From 1997 through 1999, respondent prescribed the following
12 controlled substances and/or dangerous drugs for his wife, L.J.:

20 B. The standard of practice is for a psychiatrist to use
21 benzodiazepines and opiates with caution in patients with a history of substance abuse and to
22 monitor such patients' use of medications for abuse. L.J. has admitted that she is a long time
23 abuser of alcohol and opiates. She has gone through at least seven drug and alcohol
24 rehabilitation programs in the past fifteen years. Respondent was and is fully aware of his wife's
25 abuse of alcohol and controlled substances. He was also aware, or should have been aware, that
26 she was receiving prescriptions concurrently from other physicians. Nevertheless, there is no
27 documentation that he was monitoring L.J.'s use of multiple benzodiazepines and other
28 dangerous drugs, nor is there documentation that there was a medical indication for the multiple

1 concurrent prescriptions of diazepines and other dangerous drugs.

2 C. In the course of his prescribing for L.J., respondent engaged in
3 excessive prescribing, either by exceeding the conventional dose range for the prescribed
4 medication or by prescribing drugs of the same class, e.g. benzodiazepines, concurrently. While
5 some therapies appeared consistent with a treatment strategy for treatment-resistant depression,
6 respondent did order and/or did not record baseline renal or thyroid function tests, nor did he
7 document any plan to monitor L.J. for potential hepatic toxicity as required by the standard of
8 care.

9 D. Respondent failed to maintain any medical records for treatment
10 of his wife, L.J.. The standard of practice is for a psychiatrist to document an initial psychiatric
11 assessment and treatment plan and to document each outpatient visit with a progress note
12 recording patient complaints, objective findings, an assessment of the response to treatment and
13 any revisions in diagnosis or treatment plan. There is no documentation by respondent of an
14 initial psychiatric assessment of L.J., a treatment plan, progress notes or laboratory results
15 monitoring her response to the various prescribed drugs.

16 **SECOND CAUSE FOR DISCIPLINE**

17 **(Gross Negligence/Negligence/Incompetence)**

18 23. Paragraphs 21 and 22 are incorporated herein by reference as if fully set
19 forth.

20 24. Respondent is subject to disciplinary action under section 2234 (b), (c)
21 and/or (d) in that the respondent's acts of prescribing controlled substances and/or dangerous
22 drugs to his wife L.J. over a period of years without examination, monitoring and careful records,
23 particularly taking into account respondent's knowledge of her abuse of opiates and alcohol,
24 constituted gross negligence and/or repeated acts of negligence and/or incompetence.

25 **THIRD CAUSE FOR DISCIPLINE**

26 **(Unprofessional Conduct/Multiple Role Relationships)**


27 25. Paragraphs 21 and 22 are incorporated herein by reference as if fully set
28 forth.

10 **INTERPRETER:** Pursuant to section 11435.20 of the Government Code, the
11 hearing shall be conducted in the English language. If a party or a party's witness does not
12 proficiently speak or understand the English language and before commencement of the hearing
13 requests language assistance, an agency subject to the language assistance requirement in section
14 11435.15 of the Government Code shall provide a certified interpreter or an interpreter approved
15 by the administrative law judge conducting the proceedings. The cost of providing the
16 interpreter shall be paid by the agency having jurisdiction over the matter if the administrative
17 law judge or hearing officer so directs, otherwise by the party for whom the interpreter is
18 provided. If you or a witness require the assistance of an interpreter, ample advance notice of


