JOSEPH ANTHONY CHIOTA, JR., M.D., being duly sworn, deposes and says:

That on or about August 21, 1987, I was licensed to practice as a physician in the State of New York, having been issued License No. 171975 by the New York State Education Department.

My current address is 1024 CRCASSILE AS A Manage of the Office of Professional Medical Conduct of any change of my address.

I am currently subject to OPMC Order no. 94-81 [henceforth "Original Order", which was issued upon an Application For Consent Order signed by me on May 19, 1994 (henceforth "5/19/94 Application")], as modified by a Modification Order [henceforth "First Modification Order", which was issued upon an Application to Modify Prior Consent Order signed by me on February 11,1995 (henceforth "2/11/95 Application")] The Original Order and First Modification Order, and the Applications underlying each are attached to the instant Application, and are made a part hereof.

In light of:

- The fact that I am currently subject, in New York State, to a tolled probationary period and terms;
- The fact that I have performed, in the State of Louisiana, in excess of 100 supervised PTCA procedures subject to supervision substantially similar to

that set forth in the NYS terms; and

 The fact that I have no current intention to resume medical practice in New York State, resulting in the likelihood that I would, in the absence of a modification of the prior Orders, be permanently subject to a tolled probationary term;

I hereby apply to the State Board for Professional Medical Conduct, through its Chairman, for a further Order (henceforth "Second Modification Order"), modifying the Original Order, as modified by the First Modification Order, as follows:

- I) I ask the Board to accept as substantial compliance with the retraining aspect of the heretofore tolled probationary period and terms my performance of in excess of 100 PTCA's in the State of Louisiana. In furtherance of this request, I submit, in conjunction with this Application, a detailed report by my Louisiana supervisor, evaluating my performance of these procedures.
- 2) I ask that the Board vacate the tolled probationary period in its entirety including the terms thereof which required a period of two years of record review *following* my performance of 100 supervised PTCA's.
- 3) In partial consideration of the granting of this Application, if I ever resume the practice of medicine in New York State, (although I do not presently intend to resume such practice) I hereby consent, irrevocably and in advance, to the issuance by the Chairperson of the Board, in the Chairperson's unfettered discretion, of a nondisciplinary monitoring order, subject to the provisions of New York Public Health Law §230(17) but without the requirement of presentation to a committee, and opportunity to be heard, prescribed by that section. Such monitoring order (if and when issued), and my consent thereto, does and shall

not constitute a disciplinary action against me, pending or actual, under the New York Public Health Law. I agree that such a nondisciplinary order, if and when issued, shall have the same force and effect as if issued after a proceeding as prescribed by §230(17) and shall not be subject to appeal. I understand and agree that failure to comply with such an order, if and when issued, is defined to be professional misconduct by N.Y. Educ. Law §6530(15).

4) In further consideration of the granting by the Board of the instant Application, I hereby consent that I be ordered to, and agree that I shall maintain, at all times, a current New York State registration of my New York State license to practice medicine.

I hereby make this Application to the State Board for Professional Medical Conduct (the Board) and request that it be granted by execution, by the Chairperson of the State Board for Professional Medical Conduct, of the attached Second Modification Order.

I am making this Application of my own free will and accord and not under duress, compulsion or restraint of any kind or manner. In consideration of the Board's granting of this Application, I fully, freely, and with the advice of Counsel, waive any right I may have to appeal or otherwise challenge the validity of the said Second Modification Order.



Dear Sirs,

I am addressing this letter to you as Director of the Cardiac Catheterization Laboratory at Columbia Medical Center of Southwest Louisiana in Lafayette, Louisiana. Our program is very busy with over ten invasive/interventional cardiologists and approximately 2000 procedures performed each year. As Director it fell upon me to act as Mentor and supervise the interventional practice of Joseph A. Chiota Jr., MD.. In accordance with your stipulation, I supervised Dr. Chiota in more than one hundred PTCA procedures (120 cases) starting in March 1995 and ending February 1996.

For his first 25 cases I was physically present in the Cath Lab, for his second 25 cases I was present in the Control Room of the Cath Lab, and for the final 70 cases I was always available in the Department. Prior to each case, I reviewed the indications for the procedure with Dr. Chiota, and in all cases found his case selection to be sound. During each directly supervised case I observed his procedural skills and procedural judgment, which proved to be sound as well. I personally reviewed each case for complications by discharge (if any.) All of his cases were presented for departmental review in our Catheterization Conference, which is held at the end of each day.


As his mentor, I personally reviewed all documentation; including histories, physical exams, progress notes, procedure notes, catheterization reports, etc.. I found his documentation to be excellent. All of his cases had the appropriate Cardiovascular Surgical and Anesthesia Consultations. In every case he had reviewed pre-procedure blood work, and he was always readily available for postprocedural care. All 120 patients were discharged in good condition.

Dr. Chiota's PTCA success rate was greater than 95%. His emergency by-pass surgery rate was less than 1%. Dr. Chiota's death by discharge rate was 0%. No significant myocardial infarctions were noted. One hematoma requiring transfusion was noted in a patient given thrombolytic agents. No strokes or TIAs were seen. No vessel perforation was noted.

As stated above Dr. Chiota had a superior PTCA success rate, very few complications, and no hospital mortality. His case selection was excellent, his procedural skills superior, and his documentation was also superior. His overall medical judgment was superior, and his post-procedure care was superior.

TERMS OF PROBATION

- JOSEPH ANTHONY CHIOTA, JR., M.D., during the period of probation, shall conduct himself in all ways in a manner befitting his professional status, and shall conform fully to the moral and professional standards of conduct imposed by law and by his profession;
- 2. That Respondent shall submit written notification to the New York State Department of Health (NYSDOH), addressed to the Director, Office of Professional Medical Conduct, New York State Health Department, Corning Tower Building, 4th Floor, Empire State Plaza Albany, New York 12237 of any employment and practice, of Respondent's residence and telephone number, of any change in Respondent's employment, practice, residence, or telephone number within or without the State of New York;
- 3. Respondent shall submit written proof from the Division of Professional Licensing Services (DPLS), New York State Education Department (NYSED), that Respondent has paid all registration fees due and owing to the NYSED and Respondent shall cooperate with and submit whatever papers are requested by DPLS in regard to said registration fees, said proof from DPLS to be submitted by Respondent to the New York State Department of Health, addressed to the Director, Office of Professional Medical Conduct, as aforesaid, no later than the first three months of the period of probation;
- 4. Respondent shall submit written proof to the NYSDOH, addressed to the Director, Office of Professional Medical Conduct, as aforesaid, that 1) Respondent is currently registered with the NYSED, unless Respondent submits written proof that Respondent has advised DPLS, NYSED, that Respondent is not engaging in the practice of Respondent's profession in the State of New York and does not desire to register, and that 2) Respondent has paid any fines which may have previously been imposed upon Respondent by the Board or by the Board of Regents; said proof of the above to be submitted no later than the first two months of the period of probation;
- 5. Respondent shall refrain, during the period of probation, from performing percutaneous transluminal coronary angioplasty (PTCA) procedures in New York State except, in the event Respondent elects to resume the performance of PTCA's in New York State, he may do so as set forth below:

- a) Respondent may perform PTCA's in a program consisting of the performance by him of 100 PTCA procedures subject to pre-procedure, peri-procedure, and post-procedure supervision by a mentor proposed by Respondent and subject to the approval of the Director of the Office of Professional Medical Conduct ("henceforth "Director"). The Director shall not unreasonably withhold such approval, and shall not require said program to be located in New York State as long as all requirements of supervision and reporting by said mentor are met. Said supervision shall include:
 - i) For each and every one of the 100 PTCA procedures the mentor shall review each patient case, with Respondent, for indications for and appropriateness of the procedure prior to the performance of the procedure, and for complications and appropriateness of patient care and management after the performance of the procedure.
 - ii) For each and every one of the first 50 PTCA procedures, the mentor shall be on site and shall supervise and evaluate the performance of each procedure:
 - A. During the first 25 of these procedures, the mentor shall be present in the procedure room.
 - B. During the second 25 of these procedures, the mentor may, at his or her discretion, be absent from the procedure room, but otherwise on site.
 - iii) For a period of two years beginning upon the completion of the 100th PTCA procedure, Respondent may resume performance of PTCA's without restriction, except Respondent shall meet at least quarterly with the mentor who shall evaluate Respondent's performance of PTCA through the review of Respondent's records. The selection of cases for such review shall be made at the mentor's discretion and Respondent shall provide whatever records and/or other information the mentor deems necessary for such review.
 - iv) Throughout the entire period of probation, the Respondent shall cause his mentor to provide the Director with quarterly reports

of the results of the mentors supervision, monitoring and/or evaluation of Respondent's medical practice and record keeping. The mentor shall report immediately to the Director any failure by Respondent to comply with the terms of probation or any inappropriate practices by Respondent.

- During the two year period immediately following the completion of Respondent's program of 100 PTCA procedures, he shall meet quarterly with a monitor selected by the Director, for the purpose of case and practice evaluation and review regarding the pre-procedure, peri-procedure, and post-procedure performance and management of PTCA cases, and shall provide said monitor with whatever records and/or information said monitor deems necessary for said evaluation This monitoring provision of the terms of probation shall be tolled until and unless Respondent resumes the performance of PTCA's in New York State, shall not require such monitoring until and unless he does resume such performance of PTCA's in New York State, but shall require a two year period of such monitoring beginning upon the resumption, by Respondent, of the performance of PTCA's in New York State.
- 7. Respondent shall comply with all terms, conditions, restrictions, and penalties to which he is subject pursuant to the Consent Order of the Board to which this exhibit is annexed;
- 8. So long as there is full compliance with every term herein set forth, Respondent may continue to practice his or her aforementioned profession in accordance with the terms of probation; provided, however, that upon receipt of evidence of noncompliance with, or any violation of these terms, the Director of the Office of Professional Medical Conduct and/or the Board may initiate a violation of probation proceeding and/or such other proceeding against Respondent as may be authorized pursuant to the Public Health Law.
 - 9. The terms of this probation shall expire and be of no further force and effect on the completion of the program, evaluation, and review set forth in paragraphs 5 and 6 provided at such time Respondent is in full compliance with all applicable terms set forth in this exhibit.
