After a hearing below, a BPMC Committee found the Respondent committed professional misconduct in providing treatment to four infants. The Committee voted to revoke the respondent's license to practice medicine in New York State. The Respondent timely asked the ARB to nullify the Committee's Determination, alleging that the proceeding denied the Respondent due process; the Petitioner failed to prove the charges; and the Committee imposed an excessive penalty. After reviewing the hearing record and the parties' submissions, the ARB affirmed the Committee's determination.

The Respondent appealed the ARB's determination pursuant to CPLR Article 78 and Public Health Law § 230-c(5), alleging that she was arbitrarily denied the right to file an answer and improperly deemed to have admitted the charges. The Respondent had attempted to file an answer to the charges after the 10-day deadline had passed. The Hearing Committee and the ALJ concluded that, as a matter of law, they were precluded from accepting the answer. The Appellate Division, Third Department, determined that the ALJ and Hearing Committee "had the discretion to decide whether to accept the answer." (185 A.D. 3d 1187 [App. Div. 3d Dept. 2020]). The Appellate Division remitted the matter to the ARB for further proceedings, and the

ARB remands to the Hearing Committee for determination on whether the Respondent's answer should be accepted.

## **ORDER**

NOW, with the Opinion of the Court as our basis, the ARB renders the following ORDER:

1. The ARB remands to the Hearing Committee to determine whether the Respondent's answer should be accepted; and for any further proceedings the Committee deems appropriate pursuant to the Court's Order.
