The undersigned, Howard A. Zucker, J.D., M.D., Commissioner of Health, signed a Commissioner's Summary Order for Xiang Yuan, M.D., New York License No. 295625, on August 18, 2020 (BPMC 20-218) predicated on a substantially equivalent Order suspending the Pennsylvania medical license of Xiang Yuan, M.D. by the Pennsylvania Board of State Medicine on June 29, 2020. The Pennsylvania suspension order was extended for 180 days by an order of the Pennsylvania Board of Medicine issued on September 1, 2020 following a hearing. On October 13, 2020 the Commonwealth Court of Pennsylvania modified the Pennsylvania Board of Medicine's Order and stayed the suspension of the Pennsylvania medical license of Xiang Yuan, M.D., which order of the Court is attached hereto.

It is therefore:

ORDERED, that the Commissioner's Summary Order for Xiang Yuan, M.D. (BPMC 20-218), license number 295625, dated August 18, 2020 is stayed.

AND NOW, this 31st day of August 2020, upon consideration of the testimony and evidence presented at the July 24, 2020 preliminary hearing, which established a *prima facie* case supporting the allegations in the Commonwealth's *Petition for Immediate Temporary Suspension*, it is hereby **ORDERED** that the immediate temporary suspension of the license to practice medicine in the Commonwealth of Pennsylvania of Respondent, Xiang Yuan, M.D., License No. MD427329, shall remain in effect, but in no event longer than 180 days, as required by Section 40(a) of the Medical Practice Act, Act of December 20, 1985, P.L. 457, No. 112 (the "Act"), at 63 P.S. §422.40(a), unless otherwise ordered or agreed to by the participants.
