EDWARD H. GEORGIA, M.D., says:

On or about October 19, 1967, I was licensed to practice medicine as a physician in the State of New York having been issued License No. 100231 by the New York State Education Department. I currently reside at 5300 Starline Drive, St. Cloud, FL 34771.

I am not currently registered with the New York State Education Department to practice as a physician in the State of New York.

I understand that the New York State Board for Professional Medical Conduct has charged me with one (1) specification of professional misconduct as set forth in the Statement of Charges, annexed hereto, made a part hereof, and marked as Exhibit "A."

I have not practiced medicine in New York state in many years and I do not intend to return to practice medicine in New York state. I, therefore, am applying to the State Board for Professional Medical Conduct for an agreement to allow me to surrender my license as a physician in the State of New York and request that the Board issue this Surrender Order.

I hereby agree not to contest the one (1) specification set forth in the Statement of Charges (Exhibit A).


I understand that, in the event that this proposed agreement is not granted by the State Board for Professional Medical Conduct, nothing contained herein shall be binding upon me or construed to be an admission of any act of misconduct alleged or charged against me, such proposed agreement shall not be used against me in any way, and shall be kept in strict

confidence during the pendency of the professional misconduct disciplinary proceeding; and such denial by the State Board for Professional Medical Conduct shall be made without prejudice to the continuance of any disciplinary proceeding and the final determination by a Committee on Professional Medical Conduct pursuant to the provisions of the Public Health Law.

I agree that, in the event the Board grants my Application, as set forth herein, an order of the Chairperson of the Board shall be issued in accordance with same upon issuance by the Board, which may be accomplished by mailing, by first class mail, a copy of the Order to me at the address set forth above, or to my attorney, or upon transmission via facsimile to me or my attorney, whichever is first.


I am making this agreement of my own free will and accord and not under duress, compulsion, or restraint of any kind of manner.

EDWARD H. GEORGIA, M.D., the Respondent, was authorized to practice medicine in New York state on October 19, 1967, by the issuance of license number 100231 by the New York State Education Department.

FACTUAL ALLEGATIONS

A. On or about October 17, 2000, the State of Florida Board of Medicine (hereinafter, "Florida Board"), by a Final Order (hereinafter "Florida Order"), accepted the Voluntarily Relinquishment of Respondent's license to practice medicine, based on practicing the profession when his license had expired.

B. The conduct resulting in the Florida Board's disciplinary action against Respondent would constitute misconduct under the laws of New York state, pursuant to the following sections of New York state law:

1. New York Education Law §6530(16) (failure to comply with federal, state, or local laws, rules, or regulations governing the practice of medicine).

SPECIFICATION

Respondent violated New York Education Law §6530(9)(d) by having voluntarily relinquished his license to practice medicine or having other disciplinary action taken after a disciplinary action was instituted by a duly authorized professional disciplinary agency of another state, where the conduct resulting in the voluntarily relinquishment of his license or other disciplinary action would, if committed in New York state, constitute professional misconduct under the laws New York state, in that Petitioner charges:

1. The facts in paragraphs A and/or B.
