**James Peter Kartell, M.D., says:**

On or about September 14, 1967, I was licensed to practice medicine as a physician in the State of New York having been issued License No. 099835 by the New York State Education Department. I currently reside at the Massachusetts Correctional Institution in Concord, MA. I am not currently registered with the New York State Education Department to practice as a physician in the State of New York.

I understand that the New York State Board for Professional Medical Conduct has charged me with one (1) specification of professional misconduct as set forth in the Statement of Charges, annexed hereto, made a part hereof, and marked as Exhibit "A."

I am applying to the State Board for Professional Medical Conduct for an agreement to allow me to surrender my license as a physician in the State of New York and request that the Board issue this Surrender Order.

I hereby agree not to contest the one (1) specification set forth in the Statement of Charges (Exhibit A).


I understand that, in the event that this proposed agreement is not granted by the State Board for Professional Medical Conduct, nothing contained herein shall be binding upon me or construed to be an admission of any act of misconduct alleged or charged against me, such

proposed agreement shall not be used against me in any way, and shall be kept in strict confidence during the pendency of the professional misconduct disciplinary proceeding; and such denial by the State Board for Professional Medical Conduct shall be made without prejudice to the continuance of any disciplinary proceeding and the final determination by a Committee on Professional Medical Conduct pursuant to the provisions of the Public Health Law.

I agree that, in the event the Board grants my Application, as set forth herein, an order of the Chairperson of the Board shall be issued in accordance with same upon issuance by the Board, which may be accomplished by mailing, by first class mail, a copy of the Order to me at the address set forth above, or to my attorney, or upon transmission via facsimile to me or my attorney, whichever is first.

I am making this agreement of my own free will and accord and not under duress, compulsion, or restraint of any kind of manner.





**STATEMENT  
OF  
CHARGES**

**JAMES PETER KARTELL, M.D.**, the Respondent, was authorized to practice medicine in New York state on September 14, 1967, by the issuance of license number 099835 by the New York State Education Department.

**FACTUAL ALLEGATIONS**

A. On or about July 19, 2000, in the Superior Court, Essex County, Massachusetts, the Respondent was convicted of Voluntary Manslaughter and was sentenced to five (5) to eight (8) years confinement at hard labor.

B. The conduct resulting in the Massachusetts conviction against Respondent would constitute misconduct under the laws of New York state, pursuant to the following sections of New York state Penal law:


1. New York Penal Law §125.20 (Voluntary Manslaughter).

**SPECIFICATION**

Respondent is guilty of violating New York Education Law §6530(9)(a)(iii) by reason of having been convicted of committing a crime under the law of another jurisdiction and which, if committed in New York state, constitute professional misconduct under the laws of New York state, in that Petitioner charges:
