ARNOLD SAMUEL NELSON, M.D., (Respondent) deposes and says:

That on or about September 17, 1969, I was licensed to practice as a physician in the State of New York, having been issued License No. 104670 by the New York State Education Department.

My current address is 518 East First Street, Tucson, AZ 85705 and I will advise the Director of the Office of Professional Medical Conduct of any change of my address within thirty (30) days thereof.

I am currently subject to BPMC Order No. 00-325, dated November 14, 2000, annexed hereto, made a part hereof, and marked as Exhibit I (hereinafter "Original Order"), which was issued upon a Consent Agreement and Order signed by me on November 1, 2000, (hereinafter "November 1, 2000, Consent Agreement"), adopted by the Original Order.

I apply, hereby, to the State Board for Professional Medical Conduct for a Modification Order (hereinafter "Modification Order"), modifying the Original Order, as follows: to delete the paragraph in the Original Order that states:

Five years probation under the same terms and conditions set forth in the Arizona Board of Medical Examiners, October 4, 1999, Findings and Fact, Conclusions of Law, and Order for Probation, all tolled until I return to the State of New York and resume the active practice of medicine in New York State.

substituting therefore:

I shall never activate my registration to practice medicine in New York state or seek to reapply for a license to practice medicine in New York state.

The Modification Order to be issued will not constitute a new disciplinary action against me, but will substitute the proposed language for the above described language in the Original Order.

I am making this Application of my own free will and accord and not under duress, compulsion or restraint of any kind or manner, and seek the anticipated benefit of the requested Modification. In consideration of the value to me of the acceptance by the Board of this Application, I knowingly waive any right I may have to contest the Original Order or the Modification Order for which I apply, whether administratively or judicially, and ask that the Board grant this Application.

SAMUEL ARNOLD NELSON, M.D., (Respondent being duly sworn deposes and says:

That on or about September 17, 1969 I was licensed to practice as a physician in the State of New York, having been issued License No. 104670 by the New York State Education Department.

My current address is 518 East First Street, Tucson, Arizona 85705 and I will advise the Director of the Office of Professional Medical Conduct of any change of my address within 30 days of any such change.

I understand that the New York State Board of Professional Medical Conduct has charged me with one (2) specifications of professional misconduct.

A copy of the Statement of Charges is annexed hereto, made a part hereof, and marked as Exhibit "A."

I do not contest the two (2) specifications, in full satisfaction of the charges against me, hereby agreed to the following penalties:

Five years probation under the same terms and conditions set forth in the Arizona Board of Medical Examiners, October 4, 1999, Findings and Fact, Conclusions of Law, and Order for Probation, all tolled until I return to the state of New York and resume the active practice of medicine in New York state.

I further agree that the Consent Order for which I hereby apply shall impose the following conditions:

That, except during periods of actual suspension, Respondent shall maintain active registration of Respondent's license with the New York State Education Department Division of Professional Licensing Services, and pay all registration fees. This condition shall be in effect beginning thirty days after the effective date of the Consent Order and will continue while the licensee possess his/her license; and

That Respondent shall fully cooperate in every respect with the Office of Professional Medical Conduct (OPMC) in its administration and enforcement of this Order and in its investigation of all matters regarding Respondent. Respondent shall respond in a timely manner to each and every request by OPMC to provide written periodic verification of Respondent's compliance with the terms of this Order. Respondent shall meet with a person designated by the Director of OPMC as directed. Respondent shall respond promptly and provide any and all documents and information within Respondent's control upon the direction of OPMC. This condition shall be in effect beginning upon the effective date of the Consent Order and will continue while the licensee possesses his/her license.

I hereby stipulate that any failure by me to comply with such conditions shall constitute misconduct as defined by New York State Education Law §6530(29).

I agree that in the event that I am charged with professional misconduct in the future, the agreement and order shall be admitted into evidence in that proceeding.

I hereby make this Application to the State Board for Professional Medical Conduct (the Board) and request that it be granted.


I understand that, in the event that this Application is not granted by the Board, nothing contained herein shall be binding upon me or construed to be an admission of any act of misconduct alleged or charged against me, such Application shall not be used against me in any way and shall be kept in strict confidence during the pendency of the professional misconduct disciplinary proceeding; and such denial by the Board shall be made without prejudice to the continuance of any disciplinary proceeding and the final determination by the Board pursuant to the provisions of the Public Health Law.



STATEMENT
OF
CHARGES

Arnold Samuel Nelson, M.D., the Respondent, was authorized to practice medicine in New York state on September 17, 1969, by the issuance of license number 104670 by the New York State Education Department.

FACTUAL ALLEGATIONS

A. On or about October 4, 1999, the Arizona Board of Medical Examiners (hereinafter "Arizona Board"), by a Finding of Fact, Conclusions of Law, and Order for Probation (hereinafter "Arizona Order"), placed the Respondent on five (5) years probation and required Continuing Medical Education courses, based on his failure to maintain adequate records for patients, changing medications without justification, not altering medication protocol when faced with evidence of abuse of medication by patients, post-dating prescriptions, and failure to order appropriate laboratory studies.

B. The conduct resulting in the Arizona Board's disciplinary action against Respondent would constitute misconduct under the laws of New York state, pursuant to the following sections of New York state law:

1. New York Education Law §6530(3) (negligence on more than one occasion);
2. New York Education Law §6530(16) (failure to comply with federal, state, or local laws, rules, or regulations); and/or

3. New York Education Law §6530(32) (failing to maintain adequate records for each patient).

SPECIFICATIONS

FIRST SPECIFICATION

Respondent violated New York Education Law §6530(9)(b) by reason of having been found guilty of improper professional practice or professional misconduct by a duly authorized professional disciplinary agency of another state, where the conduct upon which the finding was based would, if committed in New York state, constitute professional misconduct under the laws of New York state, in that Petitioner charges:

1. The facts in paragraphs A and/or B.

SECOND SPECIFICATION

Respondent violated New York Education Law §6530(9)(d) by reason of having had disciplinary action taken after a disciplinary action was instituted by a duly authorized professional disciplinary agency of another state, where the conduct resulting in the disciplinary action would, if committed in New York state, constitute professional misconduct under the laws of New York state, in that Petitioner charges:

2. The facts in paragraphs A and/or B.
