

**INTERIM
DETERMINATION**

A Hearing having been convened before a Committee of the State Board for Professional Medical Conduct relative to a Statement of Charges dated March 17, 1999 and which charges formed the basis for a Summary Order of the Commissioner, dated March 17, 1999, that the Respondent cease the practice of medicine; and

The Hearing on the charges having been concluded on July 9, 1999 and the Committee having heard all the evidence on the charges and on the issue of whether the Respondent would pose an imminent danger to the health of the people if he were permitted to resume the practice of medicine after the expiration of 90 days from the Summary Order in this proceeding, and due deliberation having been had on the issue of imminent danger pursuant to Public Health Law Section 230(12);

It is the determination of the Committee to recommend to the Commissioner that the Respondent will NOT pose an imminent danger to the people if he shall be permitted to resume the practice of medicine, PROVIDED THAT the Respondent shall not treat female patients without the presence of a female chaperone, and the supervisory physician of the practice where Respondent practices or of any hospital where Respondent may see patients or have privileges, shall be responsible for ensuring the presence of a chaperone in the room for all female patients that are treated by the Respondent.
