AND ORDER

MOHAMMAD YOUSEF SAMARA, M.D., (Respondent) being duly sworn deposes and says:

That on or about December 19, 1995, I was licensed to practice as a physician in the State of New York, having been issued License No. 201758 by the New York State Education Department.

My current address is 8030 West Crawford Avenue, Milwaukee, WI 53220,

I understand that the New York State Board For Professional Medical Conduct has charged me with two (2) specifications of professional medical misconduct.

A copy of the Statement of Charges made a part hereof, and marked as Exhibit "A."

I do not to contest the two (2) specifications, in full satisfaction of the charges against me.

The New York State Department of Health has offered to settle this matter by my agreeing to a Censure and Reprimand and, henceforth, that I keep my registration in the State of New York active. However, since I have not practiced medicine in New York state since 2001, and I do not intend to return to practice medicine in New York state,

I agree, therefore, in lieu of the settlement offered by the State of New York:

to continue to never activate my registration to practice medicine in the State of New York or seek to reapply for a license to practice medicine in the State of New York.

I, hereby, stipulate that any failure by me to comply with such conditions shall constitute misconduct as defined by New York State Education Law §6530(29).

I, hereby, make this Application to the State Board for Professional Medical Conduct (the Board) and request that it be granted.

I understand that, in the event that this Application is not granted by the Board, nothing contained herein shall be binding upon me or construed to be an admission of any act of misconduct alleged or charged against me, such Application shall not be used against me in any way and shall be kept in strict confidence during the pendency of the professional misconduct disciplinary proceeding; and such denial by the Board shall be made without prejudice to the continuance of any disciplinary proceeding and the final determination by the Board pursuant to the provisions of the Public Health Law.

I agree, that in the event the Board grants my Application, as set forth herein, an Order of the Chairperson of the Board shall be issued in accordance with same. I agree that such order shall be effective upon issuance by the Board, which may be accomplished by mailing, by first class mail, a copy of the Consent Order to me at the address set forth in this agreement, or to my attorney, or upon transmission via facsimile to me or my attorney, whichever is earliest.

I am making this Application of my own free will and accord and not under duress, compulsion or restraint of any kind or manner. In consideration of the value to me of the acceptance by the Board of this Application, allowing me to resolve this matter without the various risks and burdens of a hearing on the merits. I knowingly waive any right I may have to contest the Consent Order for which I hereby apply, whether administratively or judicially, and ask that the Application be granted.

MOHAMMAD YOUSEF SAMARA, M.D., the Respondent, was authorized to practice medicine in New York state on December 19, 1995, by the issuance of license number 201758 by the New York State Education Department.

FACTUAL ALLEGATIONS

- A. On or about September 15, 2004, the State of Michigan, Department of Community Health, Bureau of Health Professions, Board of Medicare, Disciplinary Subcommittee, (hereinafter "Michigan Board") by a Consent Order (hereinafter "Michigan Order"), placed Respondent on six (6) months probation with terms and fined him \$250.00, based on negligence on more than one occasion.
- B. The conduct resulting in the Illinois Board's disciplinary action against Respondent would constitute misconduct under the laws of New York State, pursuant to the following sections of New York State law:
 - 1. New York Education Law §6530(3) (negligence on more than one occasion)

Respondent violated New York State Education Law §6530(9)(b) by having been found guilty of improper professional practice or professional misconduct by a duly authorized professional disciplinary agency of another state where the conduct upon which the finding was based would, if committed in New York state, constitute professional misconduct under the laws of New York state, in that Petitioner charges:
