This Determination and Order shall be deemed effective upon receipt **or** seven (7) days after mailing by certified mail as per the provisions of §230, subdivision 10, paragraph (h) of the New York State Public Health Law.

Five days after receipt of this Order, you will be required to deliver to the Board of Professional Medical Conduct your license to practice medicine **if said license has been revoked, annulled, suspended or surrendered**, together with the registration certificate. Administrative Law Judge James F. Horan drafted the Determination

After a hearing below, a BPMC Committee determined that the Respondent committed professional misconduct following the Respondent's New York felony convictions for engaging in crimes involving the no-fault insurance system. The Committee voted to revoke the Respondent's license to practice medicine in New York State and to fine the Respondent \$10,000.00. The Respondent then filed a notice requesting administrative review pursuant to New York Public Health Law (PHL) § 230-c (McKinney 2010). The ARB considers that notice is now withdrawn after the Respondent failed to file a timely review brief.

Under PHL § 230-c(4)(a), either the Department or the licensee may request review over a Committee Determination by filing a notice within fourteen days from the Committee's Determination and then filing a review brief within thirty days from filing the notice. The Committee's Determination went to the parties by certified mail on October 28, 2010. The Respondent's counsel mailed a review notice in this case on December 1, 2010. The Administrative Officer for the ARB then advised the parties that the review brief would be due on January 10, 2011 and that the ARB would consider in the review whether the Respondent filed a timely review notice. The ARB received no review brief on January 10, 2011 and no brief since that date.

The failure to submit the brief amounts to a failure to perfect the review notice. This exhausts the administrative remedies in this case.


