I am currently subject to Consent Order BPMC No. 11-261 (hereinafter "Original Order"), annexed hereto, made a part, hereof, and marked as Exhibit 1, that was issued on November 1, 2011. I am also subject to Modification Order BPMC No. 11-261 (hereinafter "Modification Order"), annexed hereto, made a part, hereof, and marked as Exhibit 2, that was issued on May 3, 2012.

The Modification Order II to be issued will not constitute a new disciplinary action against me, but will substitute the proposed language for the above described language in the Original Order. 

OF

CHARGES

TUAN ANH HUYNH, M.D., Respondent, was authorized to practice medicine in New York state on September 28, 2001, by the issuance of license number 222912 by the New York State Education Department.

#### FACTUAL ALLEGATIONS

- On or about October 15, 2010, the North Carolina Medical Board, (hereinafter "North Carolina Board"), by Consent Order (hereinafter "North Carolina Order"), REPRIMANDED Respondent and LIMITED AND RESTRICTED Respondent's ability and authorization to prescribe controlled substances in that Respondent was PROHIBITED from prescribing controlled substances classified as Schedule II, II-N, III, III-N or IV under the federal Controlled Substances Act unless given written permission to do so by the North Carolina Board. The North Carolina Board also PROHIBITED Respondent from prescribing controlled substances for the treatment of chronic pain and required respondent to complete a Category I CME Record Keeping Course within 6 months of the date of the North Carolina Order. The North Carolina Board found that Respondent's pain management for Patient's A-D was below the standard of care in that Respondent's records often did not contain information sufficient to support a diagnosis of the pain being treated. On or about October 20, 2010, the North Carolina Board, by Supplemental Consent Order, amended the North Carolina Order by permitting Respondent to prescribe controlled substances classified as Schedule II, II-N, III-N or Schedule IV controlled substances under the Federal Controlled Substances Act until 5:00 p.m., November 12, 2010 and prohibited Respondent from evaluating, assessing, or treating patients for chronic pain who were not patients of Respondent prior to October 15, 2010.
- B. The conduct resulting in the North Carolina Board disciplinary action against Respondent would constitute misconduct under the laws of New York State, pursuant to the following sections of New York State law:

- New York Education Law §6530(3) (negligence on more than one occasion);
  - New York Education Law §6530(32) (failure to maintain an accurate record).

CHARGES

TUAN ANH HUYNH, M.D., Respondent, was authorized to practice medicine in New York state on September 28, 2001, by the issuance of license number 222912 by the New York State Education Department.

#### **FACTUAL ALLEGATIONS**

- On or about October 15, 2010, the North Carolina Medical Board, (hereinafter "North Carolina Board"), by Consent Order (hereinafter "North Carolina Order"), REPRIMANDED Respondent and LIMITED AND RESTRICTED Respondent's ability and authorization to prescribe controlled substances in that Respondent was PROHIBITED from prescribing controlled substances classified as Schedule II, II-N, III, III-N or IV under the federal Controlled Substances Act unless given written permission to do so by the North Carolina Board. The North Carolina Board also PROHIBITED Respondent from prescribing controlled substances for the treatment of chronic pain and required respondent to complete a Category I CME Record Keeping Course within 6 months of the date of the North Carolina Order. The North Carolina Board found that Respondent's pain management for Patient's A-D was below the standard of care in that Respondent's records often did not contain information sufficient to support a diagnosis of the pain being treated. On or about October 20, 2010, the North Carolina Board, by Supplemental Consent Order, amended the North Carolina Order by permitting Respondent to prescribe controlled substances classified as Schedule II, II-N, III-N or Schedule IV controlled substances under the Federal Controlled Substances Act until 5:00 p.m., November 12, 2010 and prohibited Respondent from evaluating, assessing, or treating patients for chronic pain who were not patients of Respondent prior to October 15, 2010.
- B. The conduct resulting in the North Carolina Board disciplinary action against Respondent would constitute misconduct under the laws of New York State, pursuant to the following sections of New York State law:

- New York Education Law §6530(3) (negligence on more than one occasion);
  - New York Education Law §6530(32) (failure to maintain an accurate record).

## SPECIFICATIONS FIRST SPECIFICATION

Respondent violated New York Education Law §6530(9)(b) by having been found guilty of improper professional misconduct by a duly authorized professional disciplinary agency of another state where the conduct upon which the finding was based would, if committed in New York state, constitute professional misconduct under the laws of New York state, in that Petitioner charges:

#### SECOND SPECIFICATION

Respondent violated New York Education Law §6530(9)(d) by having disciplinary action taken by a duly authorized professional disciplinary agency of another state, where the conduct resulting in the disciplinary action would, if committed in New York state, constitute professional misconduct under the laws of New York state, in that Petitioner charges:
