Enclosed please find the Determination and Order (No. 13-393) of the Hearing Committee in the above referenced matter. If your license or registration certificate is lost, misplaced or its whereabouts is otherwise unknown, you shall submit an affidavit to that effect. If subsequently you locate the requested items, they must then be delivered to the Office of Professional Medical Conduct in the manner noted above.

Either the licensee or the Department may seek a review of a committee determination.

Request for review of the Committee's determination by the Administrative Review Board stays penalties other than suspension or revocation until final determination by that Board. Summary orders are not stayed by Administrative Review Board reviews.

All notices of review must be served, by certified mail, upon the Administrative Review Board and the adverse party within fourteen (14) days of service and receipt of the enclosed Determination and Order.

ORDER

A hearing was held October 17, 2013, at the offices of the New York State

Department of Health ("the Petitioner"). A Notice of Referral Proceeding and a Statement
of Charges, both dated August 9, 2013, were served upon the Respondent, Stephen

Redmond, M.D.

Pursuant to Section 230(10)(e) of the Public Health Law, William P. Dillon, M.D., Chair, William A. Tedesco, M.D., and Dennis P. Zimmerman, M.S., CRC., duly designated members of the State Board for Professional Medical Conduct, served as the Hearing Committee in this matter. David A. Lenihan, Esq., Administrative Law Judge, served as the Administrative Officer. The Petitioner appeared by James E. Dering, Esq., General Counsel, by Paul Tsui, Esq., of Counsel. The Respondent, Stephen Redmond, M.D., did not appear, although duly served. Evidence was received and transcripts of these proceedings were made. After consideration of the entire record, the Hearing Committee issues this Determination and Order.

STATEMENT OF CASE

This case was brought pursuant to Public Health Law Section 230(10) (p). The statute provides for an expedited hearing when a licensee is charged solely with a violation of Education Law Section 6530(9). In such cases, a licensee is charged with misconduct based upon a prior criminal conviction in New York State or another jurisdiction, or upon a prior administrative adjudication regarding conduct that would amount to professional misconduct, if committed in New York. The scope of an expedited hearing is limited to a determination of the nature and severity of the penalty to be imposed upon the licensee.

In the instant case, the Respondent is charged with professional misconduct pursuant to Education Law §6530(3) for practicing medicine with negligence on more than one occasion and Education Law §6530(32) for failing to maintain a record for the patient which accurately reflects the evaluation and treatment of the patient. Copies of the Notice of Referral Proceeding and the Statement of Charges are attached to this Determination and Order as Appendix 1.

FINDINGS OF FACT

The following Findings of Fact were made after a review of the entire record in this matter. Numbers below in parentheses refer to exhlbits, denoted by the prefix "Ex." These citations refer to evidence found persuasive by the Hearing Committee in arriving at a particular finding. Confilcting evidence, if any, was considered and rejected in favor of the cited evidence. All Hearing Committee findings were unanimous.

- The Respondent, Stephen Redmond, M.D., did not appear, although he was duly served. (Petitioner's Exhibit 2.)
- Respondent was authorized to practice medicine in New York State on March 10, 1972, by the issuance of license number 111871 by the New York State Education Department. (Petitioner's Ex. 3)
- 3. On or about April 17, 2012, the Medical Board of California, Department of Consumer Affairs (hereinafter 'California Board), by a Decision and Order (hereinafter "California Decision"), inter alia, had Respondent surrender his Physician's and Surgeon's Certificate No. G 21448 based on Respondent's repeated acts of negligence in the treatment of four (4) patients which included, but were not limited to, failing to contact contemporaneous treating and prescribing physicians, failing to refer patients to a comprehensive pain management specialist or psychiatrist with experience in treating substance abuse, increasing the dosage of opiates without clinical justification, prescribing very high doses of opiates for chronic (non-malignant) pain, and continuing to prescribe high doses of opioids even after complications from opioid sedation were identified. (Petitioner's Exhibit # 1)

- 4, The surrender of Respondent's license was also based on his failure to maintain adequate and accurate records in connection with his care and treatment of at least three (3) of the patients. (Petitioner's Exhibit # 1)
- 5. The conduct resulting in the California Board disciplinary action against Respondent would constitute misconduct under the laws of New York State, pursuant to the following sections of New York State Law:
- a.. New York Education Law §6530(3) (Practicing the profession with negligence on more than one occasion).
- b. New York Education Law §6530(32) (Failing to maintain a record for the patient which accurately reflects the evaluation and treatment of the patient).

VOTE OF THE HEARING COMMITTEE FIRST SPECIFICATION

"Respondent violated New York Education Law §6530(9)(b) by having been found guilty of improper professional practice or professional misconduct by a duly authorized professional disciplinary agency of another state where the conduct upon which the finding was based would, if committed in New York State, constitute professional misconduct under the laws of New York state...'

VOTE: Sustained (3-0)

SECOND SPECIFICATION

"Respondent violated New York Education Law §6530(9)(d) by having disciplinary action taken or having surrendered his license to practice medicine after a disciplinary action was Instituted by a duly authorized professional disciplinary agency of another state, where the conduct resulting in the surrender of license, revocation of license and/or other disciplinary action would, if committed in New York State, constitute professional misconduct under the laws New York State..."

VOTE: Sustained (3-0)

HEARING COMMITTEE DETERMINATION

The Respondent did not appear at the hearing, either in person or by counsel. The Administrative Law Judge, after considering the documentary evidence, which included an Affidavit of Personal Service of the Notice of Referral Proceeding and the Statement of Charges (Petitioner's Exhibit 2), ruled that the Petitioner had met the requirements of law for jurisdiction in the service of process, that jurisdiction had been established over the Respondent, and that the hearing could proceed on the merits notwithstanding the Respondent's absence.

The record in this case indicates that Respondent surrendered his California license after charges were brought against him. (See Exhibit 5) Specifically, the documentation in the record from the State of California shows that the Respondent

was charged with repeated acts of negligence in the treatment of four (4) patients which included, but were not limited to, failing to contact contemporaneous treating and prescribing physicians, failing to refer patients to a comprehensive pain management specialist or psychiatrist with experience in treating substance abuse, increasing the dosage of opiates without clinical justification, prescribing very high doses of opiates for chronic (non-malignant) pain, and continuing to prescribe high doses of opioids even after complications from opioid sedation were identified.

The Respondent did not rebut or refute the California charges and, in fact, acknowledged their validity by surrendering his license. Thus there was no dispute about the underlying facts of this case. It is noted that if the alleged acts had occurred in New York, they would have constituted medical misconduct. The Department asked for a revocation of the Respondent's license. In its deliberations, the panel considered the full range of penalties available in the case and determined, unanimously, that revocation would be appropriate.

ORDER

IT IS HEREBY ORDERED THAT:

- The specifications of professional misconduct, as set forth in the Statement of Charges, are <u>SUSTAINED</u>.
- The license of the Respondent to practice medicine in New York State is hereby REVOKED.

This Order shall be effective upon service on the Respondent in accordance with the 3.

requirements of Public Health Law Section 230(10)(h).



PLEASE TAKE NOTICE THAT:

An adjudicalory proceeding will be held pursuant to the provisions of New York Public Health Law §§230(10)(p) and New York State Administrative Procedures Act §§301-307 and 401. The proceeding will be conducted before a committee on professional conduct of the State Board for Professional Medical Conduct (Committee) on the 19th day of September, 2013, at 10:30 a.m., at the offices of the New York State Department of Health, Riverview Center, 150 Broadway, Suite 510, Albany, NY 12204-2719.

At the proceeding, evidence will be received concerning the allegations set forth in the Statement of Charges that is attached. A stenographic record of the proceeding will be made and the witnesses at the proceeding will be sworn and examined.

You may appear in person at the proceeding and may be represented by counsel who shall be an attorney admitted to practice in New York state. You may produce evidence and/or sworn testimony on your behalf. Such evidence and/or sworn testimony shall be strictly limited to evidence and testimony relating to the nature and severity of the penalty to be imposed upon the licensee. Where the charges are based on the conviction of state law crimes in other jurisdictions, evidence may be offered that would show that the conviction would not be a crime in New York State. The Committee also may limit the number of witnesses whose testimony will be received, as well as the length of time any witness will be permitted to testify.



If you intend to present sworn testimony, the number of witnesses and an estimate of the time necessary for their direct examination must be submitted to the New York State Department of Heaith, Division of Legal Affairs, Bureau of Adjudication, Riverview Center, 150 Broadway, Suite 510, Albany, NY 12204-2719, ATTENTION: HON. JAMES F. HORAN, ACTING DIRECTOR, BUREAU OF ADJUDICATION (Telephone: (518-402-0748), (henceforth "Bureau of Adjudication") as well as the Department of Health attorney indicated below, no later than ten (10) days prior to the scheduled date of the Referral Proceeding, as indicated above.

Pursuant to the provisions of New York Public Health Law §230(10)(p), you shall file a written answer to each of the charges and allegations in the Statement of Charges not less than ten (10) days prior to the date of the hearing. Any charge or allegation not so answered shall be deemed admitted. You may wish to seek the advice of counsel prior to filing such answer. The answer shall be filed with the Bureau of Adjudication, at the address indicated above, and a copy shall be forwarded to the attorney for the Department of Health, whose name appears below. You may file a written brief and affidavits with the Committee. Six (6) copies of all papers you submit must be filed with the Bureau of Adjudication at the address indicated above, no later than fourteen (14) days prior to the scheduled date of the Referral Proceeding, and a copy of all papers must be served on the same date on the Department of Health attorney, indicated below. Pursuant to §301(5) of the State Administrative Procedure Act, the Department, upon reasonable notice, will provide, at no charge, a qualified interpreter of the deaf to interpret the proceedings to, and the testimony of, any deaf person. Pursuant to the terms of New York State Administrative Procedure Act §401 and 10 N.Y.C.R.R. §51.8(b), the Petitioner demands, hereby, disclosure of the evidence that Respondent Intends to introduce at the hearing, including the names of witnesses, a list of and copies of documentary evidence, and a description of physical and/or other evidence that cannot be photocopied.

The proceeding may be held whether or not you appear. Please note that requests for adjournments must be made in writing to the Bureau of Adjudication, at the address indicated above, with a copy of the request to the attorney for the Department of Health, whose name appears below, at least five (5) days prior to the scheduled date of the proceeding. Adjournment requests are not routinely granted. Claims of court engagement will require detailed affidavits of actual engagement. Claims of illness will require medical documentation. Failure to obtain an attorney within a reasonable period of time prior to the proceeding will not be grounds for an adjournment.
