In this proceeding pursuant to New York Public Health Law (PHL) § 230-c (4)(a)(McKinney Supp. 2014), the ARB dismisses the Respondent's Notice of Review due to the Respondent's failure to perfect the Notice by filing a timely review brief.

After a hearing below pursuant to PHL $\S 230(10)(\mathrm{e})$, a BPMC Committee found that the Respondent practiced with negligence on more than one occasion, gross negligence, incompetence on more than one occasion and gross incompetence in treating four patients. The Committee found further that the Respondent failed to maintain accurate records for the four patients. In addition, the Committee found that the Respondent practiced fraudulently and willfully filed false reports in making deliberate false representations on three reappointment applications to Richmond University Medical Center. Finally, the Committee found that the Respondent practiced fraudulently by deliberately concealing information in sworn testimony at an examination before trial concerning sanctions that BPMC imposed against the Respondent in two prior disciplinary actions. The Committee voted to revoke the Respondent's License to
practice medicine in New York State. The Committee rendered their Determination on July 28, 2014.

The Respondent began the current proceeding by filing a timely Notice of Review, which the ARB received on August 11, 2014. Under PHL § 230-c(4)(a), a party has thirty days from filing the Notice to perfect the Notice by filing a timely review brief. The Administrative Officer for the ARB advised the parties by letter on August 11, 2014 that the parties had until September 11, 2014 to file review briefs. The Respondent failed to file a brief by September 11, 2014, has filed no brief in the time since September 11, 2014 and has received no extension from the ARB for filing a brief. The Petitioner requested on September 16,2014 that the ARB dismiss this matter for the Respondent's failure to file a brief.

## ORDER

NOW, with this Determination as our basis, the ARB renders the following ORDER:

1. The ARB rules that the Respondent has failed to perfect the Notice in this matter.
2. The ARB dismisses the Respondent's Notice.
